Launch

Launch of Apollo 6 will be from Pad A of Launch Complex 39 at the Kennedy Space Center. Earliest liftoff is 8 a.m. EST and the latest time is 12 noon EST on the date of launch. Flight azimuth is 72 degrees from true north.

Flight Profile and Sequence of Events

Flight Profile

The first stage of the Saturn V will carry the vehicle and Apollo spacecraft to an altitude of 36.8 statute miles (194430 feet) and 47 statute miles downrange, building up speed to 6194 miles-per-hour (9084 feet per second) during its 2 1/2 minutes of powered flight. After separation from the second stage, the first stage will continue on a ballistic trajectory that will let it fall into the Atlantic Ocean some 396 statute miles downrange from Cape Kennedy (latitude 30.2 degrees North and longitude 74.3 degrees West) about nine minutes after liftoff.

The second stage, with engines running 6.1 minutes, will propel the vehicle to an altitude of about 117 statute miles (619872 feet) some 948 statute miles downrange, building velocity to 15,405 statute miles-per-hour (22595 feet-per-second space fixed velocity). The spent stage will impact the Atlantic Ocean about 20 minutes after liftoff some 2660 statute miles from KSC, at an approximate latitude of 31.8 degrees North and longitude 35.9 degrees West.

The third stage, in its 129-second initial burn period, will place itself and the Apollo spacecraft into a circular orbit 115 statute miles above the earth. Its inclination will be a 32.56 degrees and its orbital period 88.2 minutes. Apollo 6 enters orbit at 55 degrees West longitude, 32.6 degrees North latitude at a velocity of 17,434 statute miles per hour (25571 fps).

No major propulsion systems are used during the two revolutions of the Earth parking phase, but low-level ullage and venting thrust from the Saturn V third stage will cause small changes in the orbit.

Second Third-Stage Burn

When the spacecraft passes over the western coast of the United States on the second revolution, the preignition sequence will begin for the second burn of the Saturn V third-stage. Time from liftoff will be about three hours and five minutes, about five minutes before third-stage ignition.

The stage will maneuver at rates of one degree-per-second to reach a predetermined alignment for the burn. The burn is designed to achieve a translunar coast ellipse with a 32.44 degree inclination, a 279,000 nautical-mile apogee 320,000 statute miles).

The predetermin ed attitude for this burn is a pitch angle of 38.00 degrees and a yaw angle of -1.50 measured in the launch site inertial reference system.

Engine burn is based on nominal fuel depletion, and is estimated at 328 seconds. At engine cutoff, the spacecraft attitude is 53.7 degrees pitch and 0.25 degrees yaw.

Orbital Coast and Cold Soak

After the third-stage cutoff, the spacecraft is oriented to an attitude that approximates that for the first service propulsion system burn or pitched down about 173 degrees from the inertial velocity vector, or 26 degrees from the local horizontal.

Three minutes after third-stage engine cutoff, a programmed separation signal is fed into the Apollo guidance computer (AGC) to initiate separation of the command and service modules from the Saturn V third stage. The AGC initiates a service module reaction control system burn to achieve a forward thrust. After 1.7 seconds of thrusting, the spacecraft and the launch vehicle third stage separate. Reaction control system thrusting continues for another 8.3 seconds to separate the vehicles at a rate of about two feet-per-second.

The third-stage is expected to reach an apogee of 279,000 nautical miles (367,629 statute miles) and an orbital period of 16 days, 8 hours and 31 minutes (392 hours and 31 minutes or 1,413,033 seconds), with a projected orbital lifetime of....

At thrust termination of the Saturn third-stage, a 90 second attitude-hold phase follows. Since there is no further thrusting during the attitude-hold phase, the mission requirement for a no-ullage start of the service propulsion system is met.

First Burn SP S

Ignition attitude for the first service propulsion system burn is pitch down of about 173 degrees from the inertial velocity vector, or 26 degrees from the local horizontal. The burn will last 4 minutes and 14 seconds (254 seconds) and will result in an apogee of 11,989 nautical miles (13,799 statute miles), a perigee of 18 nautical miles (20.7 statute miles). Inclination will be 32.48 degrees. Reentry velocity and flight path angle, in the event the second service propulsion system ignition does not occur, will be 32,813 fps and 6.01 degrees from the local horizontal with a resultant maximum load factor of 5.18g.

Insertion into this new ellipse will occur about 9.25 degrees North latitude, 24.21 degrees West longitude at service propulsion system engine cutoff three hours and 25 minutes after liftoff.

Earth Intersecting Coast

After service propulsion system cutoff, the spacecraft initiates a programmed reorientation maneuver to reestablish the cold soak attitude. This is a nominal 61-second maneuver. At this same time, the Apollo guidance computer begins calculation of the time to free fall to reentry (400,000 feet). The coast phase ends 25 minutes before reentry.

About two hours and 57 minutes after service propulsion system cutoff--six hours and 22 minutes after liftoff--the spacecraft reaches apogee and begins its descent. The coast phase will end about two hours 46 minutes after apogee. At this time Carnarvon, Australia, ground station will update the Apollo guidance computer with spacdcraft position, velocity and time of free fall to reentry.

Some two minutes after this update is received the Apollo guidance computer schedules the second service propulsion system ignition for two minutes later. When time of free fall to reentry reaches 540.1 seconds, command and service module reaction control system begins a 30-second ullage maneuver, which is followed immediately by service propulsion system ignition. Time from first service propulsion system cutoff if five hours 57 minutes, from liftoff nine hours 22 minutes.

Second Service Propulsion System Burn

The second burn of the service propulsion system is designed to achieve a reentry velocity of 36,500 fps (24,886 statute miles per hour, 21,626 nautical miles per hour) and a flight path angle of 6.5 degrees below the local horizontal. The burn will last about 188 seconds. Ignition attitude is about 24.8 degrees below the inertial velocity vector, or 45.6 down from the local horizontal, in pitch.

Reentry Sequence

At service propulsion system cutoff, about 240 seconds remain until reentry begins (400,000-feet altitude). During this period the command module and service module separation and the command module reentry attitude orientation maneuvers will be performed. The maneuvers occurover the West Pacific within the Guam area of coverage.

When time of free fall to reentry equals 200 seconds, the spacecraft will reorient itself with the +X axis 60 degrees above the inertial velocity vector. The attitude is such that a crew would be heads up and facing forward. This attitude remains constant until time of free fall to reentry becomes 85 seconds. At that time, physical separation occurs with the four service module reaction control system forward-firing thrusters providing a rearward push to the service module. The thrusters fire until reaction control system propellant depletion.

Nominal splashdown for the service module (spin-stabilized, non-tumbling reentry) will be about nine hours and 46 minutes after liftoff--about 18 minutes after separation--32.81 degrees North latitude and 168.52 degrees East longitude.

Allowing about five seconds after separation from command module stabilization, the guidance and navigation system will reorient the spacecraft to the predetermined reentry attitude. This attitude is 157.5 degrees angle of attack with the relative velocity vector, with the lift vector up. A crew would be heads down, facing rearward.

Reentry, considered as beginning when the spacecraft reaches 400,000 feet altitude, will occur about nine hours and 29 minutes after liftoff at 31.9 degrees North latitude and 155.0 degrees East longitude with inertial velocity of 36,500 fps (24,886 statute miles-per-hour) and an inertial flight path angle of 6.5 degrees below the local horizontal. Applying a nominal command module lift-to-drag (L over D) ratio of .334 to the reentry profile, the splash point will be 27.33 degrees North latitude and 157.18 degrees West longitude, some 2,500 nautical (2877 statute miles) downrange from reentry.

This reentry provides the criteria for certification of the command module heat shield. Those criteria are a maximum reentry heat rate of 371 British Thermal Units (BTU) per-square-foot-second, a total heat load of 37,615 BTU per-square-foot, and a maximum reentry load factor of 5.73 g. The maximum heat rate will be encountered about 66 seconds after a normal reentry, maximum load will occur at drogue deploy 14 minutes and 11 seconds after reentry.

Communications blackout will occur some 26 seconds after reentry and will last about 108 seconds. Blackout is referenced to C-Band tracking. Drogue

parachute deployment takes place 14 minutes and 11 seconds after reentry at an altitude of 23,500 feet, main parachute deployment 50 seconds later at 10,200 feet. Splashdown for a nominal mission will be nine hours 49 minutes 45 seconds after liftoff at 27.33 degrees North latitude and 157.18 degrees West longitude, or some 339 nautical miles (390 statute miles) northwest of Kauai, Hawaii, tracking station.

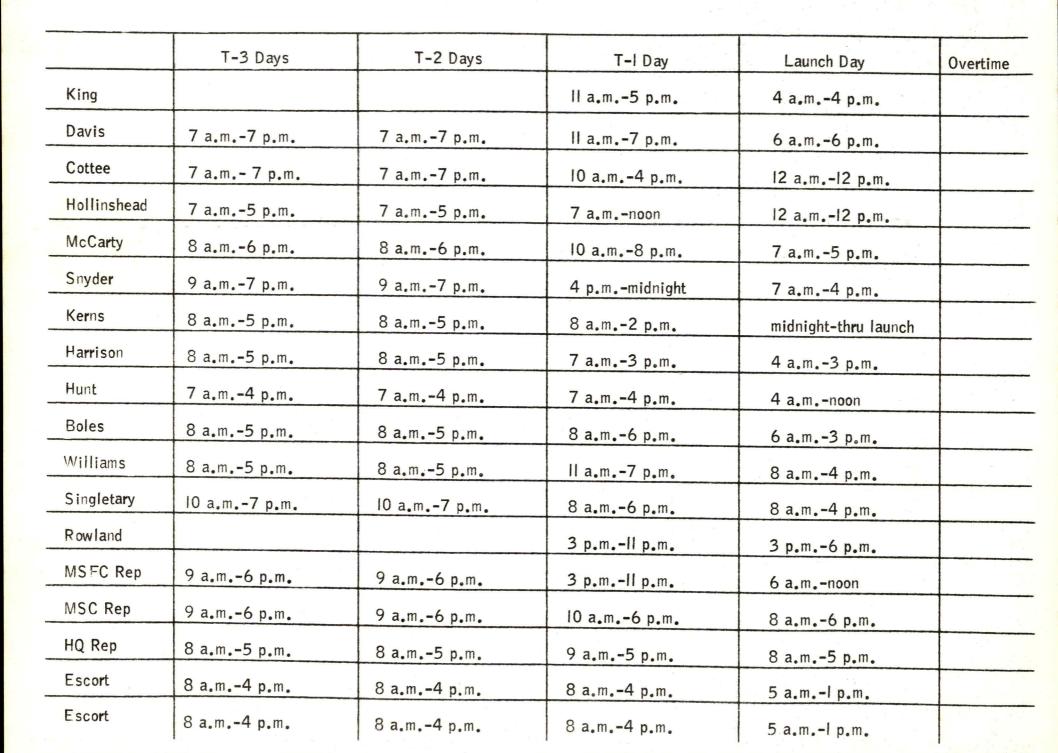

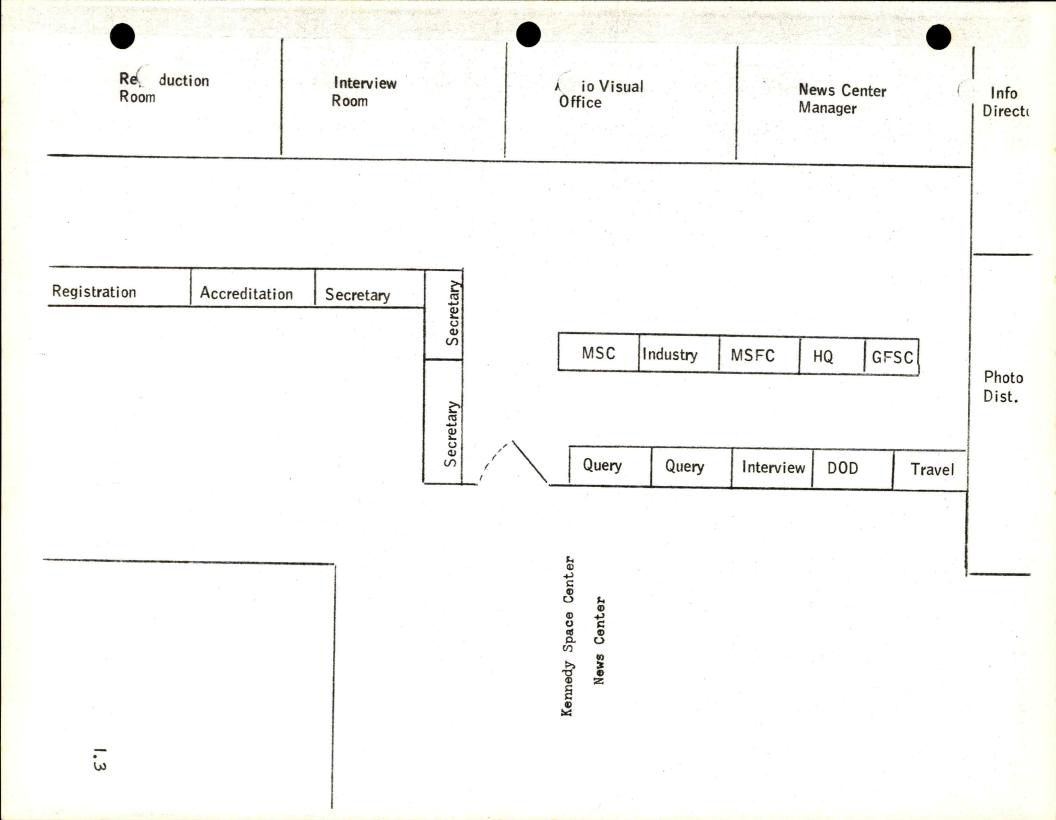

1.4 NEWS CENTER OPERATION:

The news center will open for badging at T-3 days with normal hours of operation from 7 a.m. to 7 p.m. until T-I day when the news room will be open around the clock through launch and recovery. However, the news center manager may, if the situation dictates, change the work hours to better suit the work load. If work tasks can be accomplished during a regular 8 a.m. to 5 p.m. work day, news center hours will be so changed. If the news center is required to go into operation at T-5 days, the 8 a.m. to 5 p.m. hours will be observed until T-3.

The news center will be organized to follow the attached diagram. The front row will consist of two information query desks, an interview desk, DOD desk and commercial travel desk. Immediately to the rear of and supporting the information query desk, will be mission representatives from MSFC, MSC, Goddard and OMSF.

All accreditation and secretarial work will be isolated from the information area of the news room. In the support area will be reproduction facilities, the accreditation desk, secretarial desks and facilities for ordering telephones.

All typing or other such work requests should be submitted through the news center secretary. She in turn will assign the job to an available girl. All reproduction work must be assigned through the news center secretary in order to insure work is accomplished as fast as possible and with proper priority.

Around the inner area of the news center are located offices for the news center manager, information director and photo distribution, as well as a combination escort office and interview room.

It is desired that the intercom system on the telephones be used to the largest degree practicable. The secretarial help will receive most incoming calls and refer them to the appropriate individual via the intercom. In order to reduce the noise level in the news room all personnel are urged to use the intercom system rather than shout across the room.

All questionable accreditations will be ruled upon by the news center manager, chief of KSC public information operations or information director.

All personnel in the news room should attempt, where possible, to refer any query to the query desk. If this is not possible, the individual must first check the query file to determine the official answer. If the query has not previously been answered, the individual must prepare the query and answer on the query forms provided at the query desk.

1.5 TOURS:

Tours of the Kennedy Space Center will be conducted twice daily except on T-I day when one tour will be offered at 9 a.m. A dependent tour will be conducted at I p.m. on T-I day if interest is sufficient.

If interest is not sufficient to justify twice daily tours, a 2 p.m. tour only will be conducted. If numbers do not justify use of a bus, tours will be conducted using news room station wagons or sedans.

1.6 ESCORTS:

Escort service will be provided on a need basis to both news media and tours. LTV will provide two (2) escorts daily for assignments during normal working hours. Office space will be provided for LTV escorts at the news center. Additional escorts will be available on a need basis during normal working hours. No escorts will be employed in an overtime capacity without prior approval of the news center manager. In the event of a slip in the launch schedule, escorts will be released as soon as possible.

I.7 BADGING:

Normal Apollo badges will be issued by the Kennedy Space Center. The badges will be the same as those used on Apollo 4 and will not require escort providing the wearer is enroute only to Press Site 39 via escort providing the wearer is enroute only to Press Site 39 via gate 2. The use of the badge at any other location at the KSC or CKAFC without escort will be prohibited. There will be no technician badges issued for Apollo 6 since unescorted access to the press site will be available to all news media. Badging will commence at T-3 days at the News Center and the Apollo 6 badge will be in force for all news media through plus one day. Badges will be color coded as follows:

Press -- White Contractor -- Blue Support -- Pink

Contractors will be authorized badges at the ratio of three badges for each prime contractor and one badge for each sub-contractor. Advanced badging procedures used on Apollo 4 will be used for this mission.

1.8 QUERY DESK PROCEDURES

The Query Desk Coordinator shall receive and record all technical information request, the time received, source, the response, time of response and source. Queries will be processed and responded to in the shortest possible time.

The Query Desk will assist in monitoring pool copy TWX transmissions, reproduction of copy and distribution.

The Query Desk will establish and maintain liaison with other mission information points for obtaining or giving summaries, status reports and other advisories.

The writing of necessary news releases will also be assigned as a rule to the Query Desk. Other Information Specialists may be made available by the News Center Manager for this purpose.

1.9 INTERVIEW PROCEDURES

Interviews with mission personnel will be arranged as requested by news media when their duties permit on non-interference basis.

All interviews will be arranged through the Interview Desk in the Apollo News Center.

Transportation to points of interviews for interviewees or interviewers will be provided as desired or required by the News Center Manager.

Interviews with MSC or other NASA officials not directly involved in the mission may be arranged for news media. Provisions applicable to mission personnel interviews will also apply to those with non-mission personnel.

The Apollo News Center, on request, will assist news media in obtaining interviews with NASA prime contractors or subcontractors to the extent that the request will be relayed as soon as possible to the proper public relations representative of the firm involved for action.

The Interview and Industry Desk (NASA) Coordinator will give assistance to news media and DOD representatives, as requested, in arranging interviews with DOD officials in connection with the mission. All requests for DOD interviews, however, will be the responsibility of the DOD-PIO representative.

The Interview Desk Coordinator will be responsible for recording all interview requests and the action in response.

2.1 MISSION DESCRIPTION

Launch of Apollo 6 will occur at 7 a.m. with the total length of the mission about 10 hours. The basic objectives and mission are the same as those for Apollo 4 with the spacecraft launched into a highly elliptical orbit and rammed back into the atmosphere at lunar reentry velocity.

The S-IVB and the spacecraft will be launched into a 100nm circular orbit. After two revolutions a second burn of the S-IVB (327 sec.) will send the spacecraft into an orbit with an apogee of 279,000nm miles. After separation, there will be a secondary propulsion system burn in retrograde of 250 seconds. This will put the spacecraft into an orbit with an apogee of 18,000 nm. At about nine hours into the flight a 188 second posigrade sps burn will result in a 3,500 feet per second reentry. Reentry will occur about 9 hours, 30 minutes into the mission and splash will be at about 9 hours, 50 minutes.

2.2 LAUNCH WINDOW

The Apollo 6 launch window will open no earlier than that time which will allow sufficient lighting for photographic coverage of the launch. It will close no later than that time which will allow sufficient daylight in the planned landing area to effect a safe recovery.

2.3 WEATHER RESTRICTIONS

Cloud conditions which would preclude the attainment of certain camera requirements will be a basis for hold. Mandatory requirements in this area include a minimum of three of five long range ground cameras operating. Two of the operating long range ground cameras must have a 50 per cent probability of covering each of the following trajectory events:

> MAX Q 42,000 feet LET Jettison 300,000 feet

The vehicle will not be launched when its nominal flight path will carry it through a cumulonimbus (thunderstorm) cloud formation.

The following surface wind restrictions are referenced to 60 feet above natural grade (pad height).

The launch director will assess surface winds at T-20 minutes and again prior to initiation of automatic sequence at T-3 minutes, seven seconds, and will continue to hold the count accordingly.

In the event the space vehicle is exposed to winds exceeding the specified limits, and assessment of the peak winds observed and of the extent of possible vehicle structural damage is required to determine subsequent action (e.g., proceed, or scrub).

Range safety restrictions for weather require a visibility of five miles and a ceiling of 2,000 feet.

2.4 TURNAROUND CAPABILITY

A scrub of the launch will result in the following turnaround times. All times listed are from scrub to next T-O, excluding built-in holds. Times also are dependent upon many factors and, therefore, this list is offered as a guide only.

3.2 APOLLO 6 LAUNCH VEHICLE HISTORY

The first stage of the launch vehicle arrived at KSC on March 13, the second stage on May 24 and the third stage on February 21. The instrument unit arrived on March 20, the Spacecraft Lunar Module Adapter (SLA) in February, 1967 and the Launch Escape System on November 15.

3.3 APOLLO 6 SPACECRAFT HISTORY

The Command/Service Module arrived at KSC on November 24. The Service Module was mated with the SLA on November 30 and the Command Module was mated to them on December 5. The spacecraft SLA was moved from High Bay of the MSOB to the VAB on December 9 and mated to the launch vehicle on December 10. The space vehicle was electrically mated on January 12, 1968. The space vehicle was transported to Pad A on February 6.

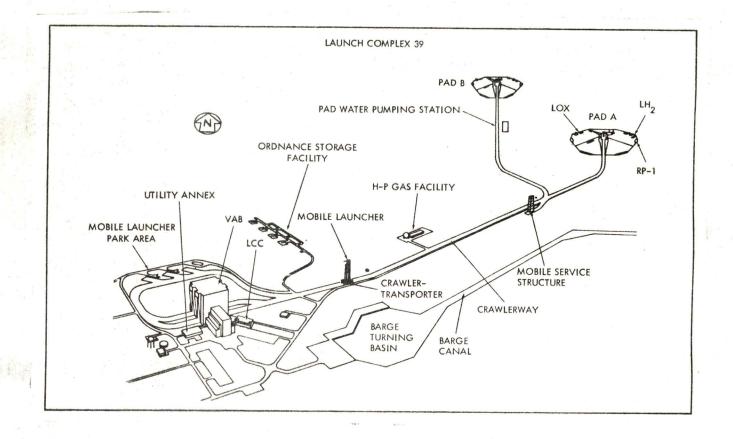

6.1 SPACECRAFT DESCRIPTION

Spacecraft 017, for Mission AS-501 is composed of a Launch Escape Tower, Command Module, Service Module, Lunar Module Adapter and a Lunar Module test article.

Command Module (CM)

The CM is made up of an inner structure, or pressure vessel, and an outer structure. A layer of insulation separates the inner and outer structures. The heat shield (outer structure) consists of: A forward heat shield, a crew compartment heat shield and an aft heat shield. Ablative material is bonded to the heat shield stainless-steel honeycomb structure.

Service Module (SM)

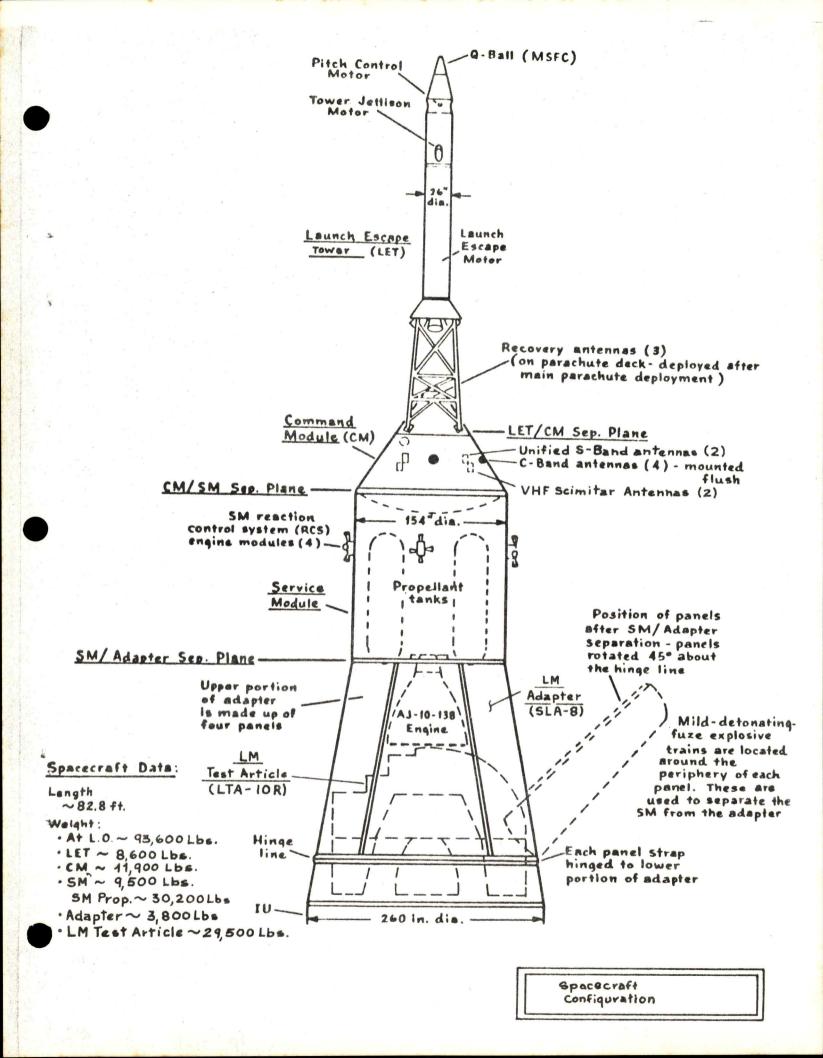

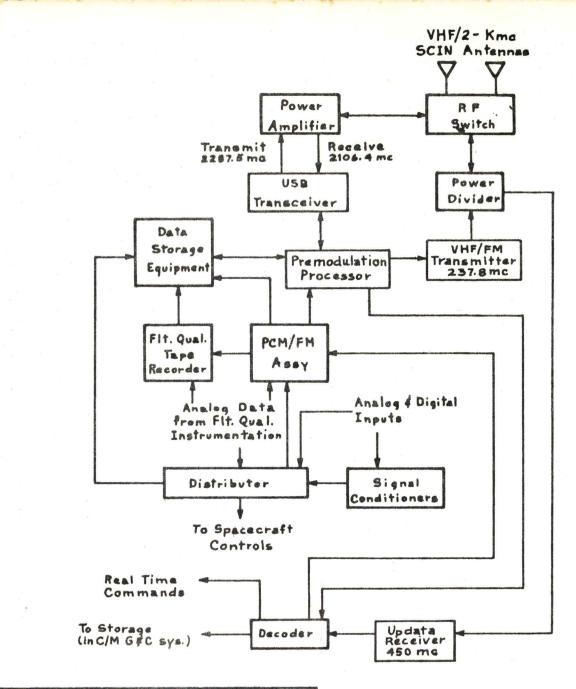

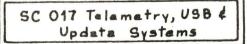

APPENDIX A - APOLLO 6 SUMMARY OPERATIONS PLAN (KSC)

I. Viewing Sites

Viewing sites will be located in the following areas:

- 1. Distinguished Visitors Site--West of bridge on NASA Causeway.
 - a. Bleacher type seating for 1000 guests.
 - b. Public address system with sufficient speakers to cover ten sets of bleachers. Public address system will include microphone and also provide prelaunch and launch commentaries.
 - c. Electricity and lighting.
 - d. Ten sanolets placed in separate groups to the right of the bleachers. (7 for men; 3 for women)
 - e. Site will be roped off to assist Security in precluding entry of unauthorized persons. KSC will provide necessary patrolmen.
 - f. Four telephones located at the Protocol Information Desk.
 - g. One hot line connecting Viewing Site with Launch Complex 39 Press Site Building.
 - h. Ambulance and emergency first aid service.
 - i. Food service (2 snack stands).
 - j. The area will be sprayed and the bleachers will be wiped down prior to arrival of distinguished visitors.

2. Dependents Viewing Site--East of bridge on NASA Causeway.

The area east of the bridge, which provides visual access of **Pad A** Complex 39, will be reserved exclusively for NASA and

contractor dependents who will drive their own automobiles to the site. AFETR dependents will be brought to the site via bus. Badges, car passes, and instructions prepared by KSC CRB will be issued to the dependents at T-5 days. Mobile food service vans and portable sanolets sufficient for 2000 dependents will be provided. Security will handle parking of vehicles and control traffic. Emergency first aid and ambulance service will be provided. Public address system speakers will be installed to provide prelaunch and launch commentaries. Dependents may view the launch from their parked automobiles or bring with them folding chairs and other comfort items as desired.

An alternate site for the dependents viewing area will be located north of the VAB, where the VIP Site was established for the Apollo 4 mission. If this site is selected, facilities and support outlined above will be provided.

- Firing Room #3--The access list for Firing Room #3 will be provided and controlled by OMSF. Protocol will provide transportation and escort for guests invited to Firing Room #3.
- 4. Contractor-Employee Site--NASA and contractor employees resident in the Kennedy Space Center may view the launch of the Apollo 6 mission from convenient areas near their place of duty as long as these areas are outside the impact limit line.

Employees will not be permitted to view the launch from the NASA Causeway.

II. LC 39 Press Site

The Press Site at LC 39 will be used for the Apollo 6 mission. A representative of KSC PIO will act as Press Site Manager, who will coordinate all support activity for the media at this location beginning with the arrival of TV pool technicians prior to the launch.

Arrangements will be made for TV pool technicians to gain access to the Press Site without escort. The remainder of the media may visit the Press Site, up to T-24 hours, by using shuttle bus service from Cocoa Beach. From T-72 hours through mission completion, news media representatives may drive to the Press Site unescorted where arrangements have been made for parking approximately 350 cars. All automobiles will carry windshield stickers for access to the parking area. Shuttle bus service from the Cape Royal to the Press Site will augment these parking arrangements.

When registering at the News Center, media representatives will select a seat in the Press Box at the LC 39 Press Site. Seats in the Press Box will be assigned on a first-come, first-served basis.

Three public relations representatives from each prime contractor, and one from each subcontractor, will be issued badges for access to the LC 39 Press Site.

III. Transportation

KSC Transportation Section will provide KSC Public Affairs Office with 8 vehicles at T-5 days for use during the mission. These vehicles will be available to PIO or Protocol as required. Mr. Arnold Richman will coordinate transportation requests.

KSC Transportation Section will provide the following additional transportation beginning at T-2 days:

1. For KSC PIO:

- a. One bus for media tours of KSC. These tours will be scheduled at 10 a.m. and 2 p.m. daily. Mr. Wright Kerns will be the tour coordinator.
- b. Two buses for shuttle service between the News Center and LC 39 Press Site. The shuttle buses will operate constantly from 8 a.m. to 6 p.m. daily from T-2 days to T-12 hours, making each round trip every 2 hours. From T-12 hours, three NASA buses will operate a shuttle service between the Cape Royal News Center and LC 39 Press Site every 30 minutes. The last bus will depart the Cape Royal at T-1 hour.

2. For Protocol:

The KSC Transportation Section will coordinate all NASA Protocol Center (NPC) transportation requirements and establish a small vehicle motor pool at NPC in Cocoa Beach. The NPC will be

located at the Quality Courts motel and will open at T-2 days.

a. All 37 and 45-passenger buses should be serviced and ready for immediate use on the days indicated below:

(1) T-2 days: 3 -- 45 passenger buses
 8 -- Sedans
 2 -- Stretchouts

- (2) T-12 hours: 22 -- 45 passenger buses
 10 -- Sedans
 6 -- Stretchouts
- b. All buses to report to the NPC (including standby buses)4 hours prior to established launch time.
- c. Buses and drivers will be under direct control of NPC after reporting. Each escort will issue instructions to the driver of the bus to which he is assigned.
- d. Guests will be advised of the numbered bus to which he/she is assigned, and requested to return to that bus during the day's activities. To insure that each guest knows his vehicle the escort will announce from time to time the number of the bus and will be standing at the door of the vehicle when departing from any location.
- e. Special guests transported to Firing Room #3 will be escorted directly to the LCC from Cocoa Beach, and buses will stand by on the east side of the building.

f. Guests and the vehicle in which they ride will be predesignated on the master list. Guests will be advised regarding their assigned transportation when obtaining badges.

IV. Communications Requirements

The following is an outline of communications support required for the Apollo 6 mission:

- 1. Distinguished Visitors Site:
 - Public address system to include microphone and enough speakers for ten sets of bleachers. Public address system linked with launch commentary.
 - b. Four telephones.
 - c. Direct line connecting Distinguished Visitor Site to LC-39
 Press Site Building.
- 2. Dependents Viewing Site:
 - a. Public address system with enough speakers for 2000 dependents.
 - b. One unlisted telephone.
- NASA Facilities: Public address system in KSC facilities will carry prelaunch and launch commentaries for all employees from T-30 minutes through the launch phase.

V. Transcripts

The MSC News Center will handle all press transcripts.

The prelaunch and postlaunch briefings will be transcribed for KSC management under the direction of the KSC PAO Contract Technical

Representative. Arrangements will be made to secure transcript typists, recording and transcribing equipment, and necessary space at KSC. Transcript typists will be Civil Service personnel furnished by KSC.

VI. Food Services and Sanitary Facilities

Food services will be provided as follows:

- LC 39 Press Site: A semi-mobile food service unit will provide food service at the Press Site from T-2 days through mission completion.
- 2. Distinguished Visitors Site: Two snack stands will be located at the Distinguished Visitors Site at T-1 day and operated through the launch.
- Dependents Viewing Site: Two mobile food service vans will provide snacks to the dependents beginning at T-4 hours through the launch.

Portable sanolets will be established at the Distinguished Visitors Site and the Dependents Viewing Site the day preceding launch.

VII. Briefings and Tours

Because of the early scheduled launch of the Apollo mission (7 a.m. EST) there will be no formal mission briefing for distinguished guests.

Where holds are expected to last 60-90 minutes, Viewing Site guests will be escorted on tours of certain KSC facilities in predesignated buses.

Tours may include a walk-in and briefing in the Astronauts' Training Facility, the VAB, and/or the VIC, time permitting.

Where holds are expected to exceed 90 minutes or more all Viewing Site visitors who desire to participate will be escorted in their assigned buses on a tour of KSC. Film showings and/or a science lecture may be included during these tours. Film showings will be held in the Training Auditorium and in the VIC.

If there have been few holds in the countdown and no complete tour of the Center conducted for guests, following the launch or in the event of the scrub, all guests who desire to participate will be provided a complete tour of CKAFS and KSC. However, those guests who wish to return to Cocoa Beach will be provided necessary escort and transportation.

VIII. Alternate Plans During Holds or Postponement

In the event of a postponement, scrub, or hold, the schedule for invited guests will be as follows:

- 1. If it is necessary to reschedule a launch, guests will automatically have a valid invitation for the rescheduled date.
- 2. If a distinguished visitor arrives at KSC and unforeseen operational difficulties slip the launch, the guest will be provided a tour of the Center if desired, and given the option of staying or returning for the launch.

- 3. Distinguished visitors encountering extended holds at the Viewing Site will be afforded tours of KSC until launch time.
- 4. Guests escorted to KSC who have received a tour but failed to view a launch will be given the option of staying or returning to witness that particular launch.
- 5. Guests who decline an invitation or terminate their visit for reasons other than indicated above normally will not be reinvited.

IX. Plans During Holds

1. Holds of less than one hour:

Guests will remain at the Distinguished Visitors Site during holds of less than one hour.

2. Holds of two hours or less:

Guests will be transported to the VIC (which will be closed to the public on launch day) or to the Training Auditorium for a film showing or science lecture, and a drive-by of the Kennedy Space Center industrial area will follow.

3. Holds of three hours or less:

Guests will be transported to the VIC for film showing or science lecture, drive-by of the KSC Industrial Area, a stop at the Astronauts' Training Facility, and a stop at the VAB.

4. Postponement of launch or post launch:

A drive-by of KSC and CKAFS will be provided on an optional basis. Remainder of transportation will return guests to Cocoa Beach.

In event of a scrub, the VIC will be opened to the public two hours later and public tours of the Center will be resumed as soon as tour buses are available.

5. Catastrophic blowup of vehicle:

All distinguished guests will be escorted to Cocoa Beach at the discretion of the Apollo Information Director or the KSC Public Affairs Office. Gate #3 will be used for emergency egress.

Dependents will egress in the event of an emergency at the direction of the KSC patrol.

X. Photography

Photographic coverage of Apollo 6 at KSC, identified in the PSRD and the KSC Photographic Test Plan, will be accomplished by Technicolor.

Technicolor will be responsible for retrieving still and motion picture news release and unprocessed pool items from Pad A as soon as Pad Safety considers the complex safe.

Technicolor will deliver all unprocessed pool items to Les Gaver or his representative at Press Site 39. All other PIO news release film will be delivered to Technicolor Film Library for processing. Contact prints will be made available for the PIO photo coordinator (Ed Harrison) who will make final selections. Technicolor will print 50 each B&W 8x10 prints and 10 each 4x5 color transparencies of selected photographs. The PIO photo coordinator will be responsible for written captions for all release prints. He will also arrange for film courier service for delivery of release prints to the News Center where the KSC News Center Manager or his representation will distribute photos to the news media.

APOLLO S/M GENERAL CONFIGURATION

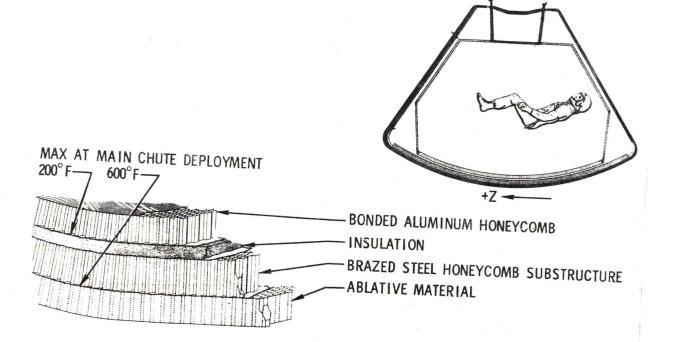


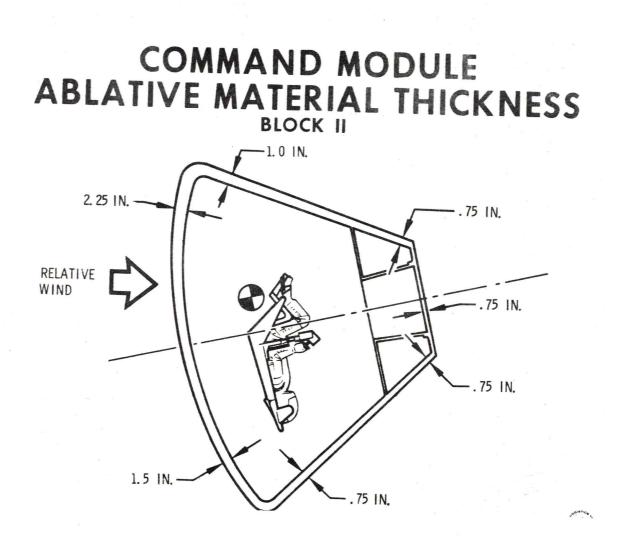




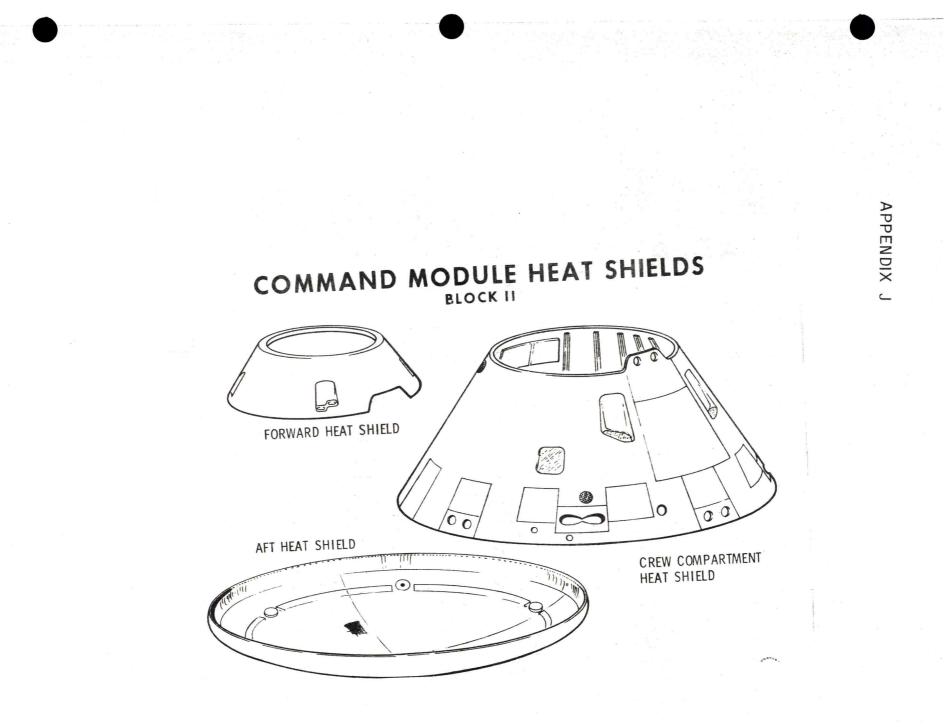
