It is said that Weiner has an affidavit from a Capt, Guiter who was attached to the General Staff at Washington in July 1943 embodying Wyman's remarks.

The day after the carousal Capt. Guiter and the other officers reported the incident to the G-2 office at Honolulu. Nothing was heard for about six weeks when the officers were called in and statements taken. Nothing further was heard of it.
