Memorandum for the Judge Advocate General.

Subject: Report of House Military Affairs Committee alleging neglect and misconduct of Colonel Theodore Wyman, Jr., and others, concerning Hawaiian and Canadian Defense Projects.

1. The recommendations contained in paragraph 5 of the memorandum dated July 10, 1944, of Major Henry C. Clausen, J. A. G. D., to Mr. Amberg, Special Assistant to the Secretary of War, on the above subject, are approved.

2. Immediately upon the appointment of a board of officers pursuant to Public Law 339, 78th Congress, to investigate the facts surrounding the Pearl Harbor catastrophe, the phases of the present matter relating thereto will be referred to such board for investigation and such other action as may be proper under the directive appointing such board.
