This Indenture made this nineteenth day of October in the year of our Lord one
 thousand eight hundred and thirty five, Between Thomas M. Princes of the County
 of Chatham and the State of North Carolina of the one part, and Stephen Moore of the
 County and State aforesaid of the other part, Witnesseth that the said Thomas M. Princes
 for and in consideration of the sum of Six hundred and fifty dollars to him in hand
 paid by the said Stephen Moore at and before the sealing and delivering of these present
 in the receipt whereof he doth hereby acknowledge, hath given granted, bargained, sold,
 aliened, released, released, and confirmed, and does by these presents give, grant, bar-
 gain and sell alien release and confirm unto the said Stephen Moore three
 several tracts or parcels of Land Situate lying and being in the County and State a-
 forsaid which is bounded as follows (to wit) Beginning at an Oak on Robinsons Creek
 and running South one hundred and thirty one pole to a black Oak bush corner of the
 Dawes line, thence East with said line sixty eight pole to a post oak, thence South
 68 1/2 pole to a Hickory, thence West 78 pole to a willow oak on Malones branch
 thence up the meanderings of said Branch to an Elm in Bolings line the
 same West crossing the Road twelve pole to 2 small Black Sacks, thence North
 372 pole to a Hickory on the bank of the creek at the mouth of a gut, thence
 down thence creek to the first station, containing by estimation one hun-
 dred acres, also one other tract or parcel, bounded as follows (to wit) Begin-
 ing at a Hickory on the bank of the creek at the mouth of the gut, and
