Lt MYERS hurt in as automobile accident and Mospitalized on Jan 25, 1944. Lt PICKET, HAS Co. assumes temporary duty as En Water Supply officer. Go "B" Leaves En control and is attached to the 179th Inf RDT.

Period 0001 to 2400 31 Jan 44

His Co CP same location. Opened W.P. at 952145 in A.M. and closed again in the evening. Now maintaining two W.P.'s at 918205 and 873238. Co. encountered much difficulty in moving into area, which was in the center of the Pontine marshes. Sent 3 trucks cut to haul mines and wire for the infantry.

Co "A": CP moved at 1400 to 848261. Entire Company attached to the 157 Inf. Corduroyed three bad spots in read 835263 to 813250 and improved read. Also improved read 857240 to 848271. Co "B": CP moved to 988153. Entire Company attached to 179 Inf. 3rd

Co "B": CP moved to 958153. Entire Company attached to 179 Inf. 3rd platoon rejoined Company. 7/5 Gerson WIA by flak on Jan 28 while manning a .50 Cal M.C. and hospitalized. 7/5 Thigpen awarded a purple Reart Medal. . Co "C": CP same location. 1st and 2nd platoons unloaded ammunition at Port of Ausio. Two platcons under En Control. 1 Platoon, Lt ENIDCES, attached to 180 Inf. Lt BRIDGES called at 2030 for 150 AP mines and 6000 yards of Concesting to be placed in 180th area, center of the beach head area on a 2000 yard front.

1. Following is a summary of operations of this Battalion for January 1944:

I. Period: January 1st to January 7th.

Co A maintained the Casale road and constructed peep trail for 157th Inf. Co B maintained and improved the Filignano-Casale road.

Co C improved 16 by-passes and constructed a three pan timber bridge in the vicinity of San Potiti-Telese area in preparation for movement of Dvisision to rest area.

H&S Co maintained Engr Dump and water points; operated a shower unit in Venafro; performed usual service functions.

II. Period: January 8th to January 17th:

Co A was relieved of duties in Casale sector by the French Engrs of 3rd DIA. Maintained road from Piedimonte to San Salvatore; constructed two stages for Division shows; constructed foot bridge at Fiacchio by-pass; 4 day period of rest and clean-up.

Co B was relieved of duties in Casale sector by French Engrs; maintained roads and bridges in San Salvatore-Telese-Amorosi sector; constructed stage for the 180th Inf; four day period of rest and clean-up.

Co C constructed 200 ft. two-span triple single Bailey bridge across the Volturno River near Amorosi. The difficulty problem of a center pier was solved by the construction of a 26 foot timber tower on the partially destroyed stone pier in the center of the river.

H&S Co performed usual service functions with stress on the maintainance of the Battalion vehicles; operated two shower units near Telese and Gioia for the use of the Division personnel.

III. Period: January 18th to 20th:

Co A training according to Division directive. Co B same as above.

Co C resting and cleanup of equipment.

HES Co continued with work of previous period.

IV. Period January 21st to January 31st: Co A prepared and moved by sea to Nettuno-Anzio sector; attached to the 157th Inf for the move and following operations; moved with the 157th Inf into defens sector on left flank of beach-head kine.

Co B prepared and moved by sea to Nettuno-Anzio sector; one platdon attached to 179th Inf for move and subsequent operations; planned to establish barrier line for 179th Inf along right fland of beach-head along Mussolini Canal.

Co C preparation and movement by sea to Nettuno-Anzio sector; one platoon attached to 180th Inf for move and subsequent operations; provided ammunition handling detail for the VI corps at Anzio.




