# Significant Requirements Changes Since Design Baseline

- Launch Date from 9/18 to 11/10 (EST)
  - Targeting November 14, 2008 (EST) launch
- FRCS loaded to mid-point
  - Implemented to increase on-orbit propellant
  - APM reduced by 245 lbs
- Main Engine #2 swap with STS-125
  - No impact to Flight Design
- PSSC deploy/separation plan updated to ensure safe relative motion with the ISS



# Significant Mission Firsts and Unique Items

#### First flight of OI-33 Flight Software

- LO2 and LH2 Prevalve Timer Modification
  - Ensures that the reference point for the start of the prevalve time delay is measured from the time the engine was first detected to be in shutdown
- MM102 Three Out SERC
  - ASC DAP sets Contingency Single Engine Roll Control flag when MECO cmd flag is set in first stage
- Increase GRTLS Aft RCS Jet Limit
  - Increases Jet Select Logic (JSL) limit on the number of jets per RCS pod available during GRTLS
  - Current limit is hard-coded at 4
  - Creates a new I-Load RCS JLIM which allows the limit to be increased
- RTLS ET Separation Improvements & Correction to RTLS ET SEP Jet Commanding
  - Addition of new pitch down maneuver during mated coast
  - Changed the maximum time automatic ET sep can be inhibited from hard-coded value to I-Load
  - Flight Control attitude error limits, body rate limits and deadbands modified to support better roll and pitch control during ET sep
  - Moved speedbrake opening from MM602 to MM601 (MECO confirmed)
- Bearing Displays
  - Added new ascent and entry bearing displays for increase situational awareness
  - Assists crew in assessing vehicle performance abort capabilities

#### First flight of OI-33 Flight Software (cont)

- Remote Control Orbiter Enhancement
  - Provides automatic capability to arm and deploy landing gear and drag chute if RCO is enabled and TAEM guidance has terminated
  - Resumption of GPS navigation during rollout if RCO capability has been enabled and MLS is no longer available
- ECAL Energy Compensation
  - Compensates the effects of phugoid motion on the orbiters estimated energy state for OPS 6 ECAL cases
- Improved GRTLS TAEM Alpha Trap
  - Modifies Alpha Recovery to Nz Hold Transition logic by employing a hysteresis function for both the arm and trigger alpha criteria
- I-Load Constraints Modification
  - Modifies I-Load constraints to cover newly created I-Loads for OI-33
- No drag for Lambert Guidance Improvements
  - Enables drag from TIG-15 seconds through TIG
  - Clean-up from a previously implemented CR
- Year End Roll Over Reset eases the roll over of FSW into a new year
  - Navigation Category GPT updated to expand the use of I-Load LAUNCH\_Year to include 3 Principle Functions
- BFS GPS Auto Update Frequency
  - Allows BFS nav to be updated with the selected GPS state at I-Load specified intervals when in automode

# **Deviations, Exceedances and Anomalies**

#### **Deviations/Exceedances**

- Contingency Abort Black Zone (CABZ) assessment required
  - Mass properties do meet the CABZ assessment criteria of liftoff weight greater than 259,000 lbm and Xcg aft of 1115.0 in.
  - OCF cycle liftoff weight = 266,777 lbm. and Xcg = 1117.9 in.
  - FRR cycle liftoff weight = 266,894 and Xcg = 1115.7 in.
  - Analysis results showed increased black zone exposure, particularly in the 3 engine out and RTLS
  - Results presented at A/E GNC panels, STS-126 Flight Director and Flight Manager, SIRB and SICB
  - Action given by SICB to perform analysis on Uplink TDDP and report back to board



#### **Deviations, Exceedances and Anomalies - Continued**

#### **Deviations/Exceedances**

- Thermal/Structural Envelope Program (TSEP) violation identified for a December EOM entry
  - Violation sent to Boeing for analysis
  - Tracked as Non-Standard Open Work closure date TBD
- No Dock PLS downweight exceeds the NEOM downweight limit by 2296 lbs.
  - Preflight thermal analysis is not required
  - Real-time analysis will be performed if required
  - Mission-specific flight rule has been submitted
- DOL I-load transfer script
  - During STS-125 TCDT, I-load transfer script failed
  - Failure traced to ftp default format mismatch
  - Manual comparison of GPC dump and I-loads verified good I-load uplink
  - Script to be altered to use correct format
  - Tracked as Non-standard Open Work, expected to be completed by 10/17

# DM Flight Design and Dynamics (Trajectory Operations) Significant Mission Firsts and Unique Items

#### ISS Phasing Strategy

- ISS reboosts on 10/02/08 and 10/30/08 of about 0.8 m/s each.
- Oct 30<sup>th</sup> burn allows for Shuttle phasing closer to the launch date which can account for slips and atmosphere perturbations.
- Provides 13 consecutive launch days with Flight Day 3 rendezvous capability. (Dot Chart provided in Backup Charts)

#### Reboost/Deboost Capability

- ATV undocked September 5, 2008
- SM engines is our current capability for STS-126 Joint Underspeed Recovery
- Propellant available for one full burn and a second half burn
  - Takes 4 days to refill SM fuel tanks after a full burn
  - 2 days will provide enough fuel for half a burn
- Full burn provides 29.5 fps delta velocity



# Significant Mission Firsts and Unique Items

#### • Pico-Satellite Solar Cell (PSSC) Deploy

- Deploy at more than 5 km below ISS is required to maintain safe long term relative motion between the PSSC and ISS. Protects start of secondary mission phase which involves PSSC thruster firings with altitude changes of 30 km.
- A minimum retrograde component of 3 fps at deploy is required to ensure a sufficient separation rate from the Shuttle after deploy.
- PSSC / Orbiter relative motion will be closely monitored in the event a retrograde orbit adjust is required prior to EOM.

#### Last mission to use Edwards Temporary Runway

- Edwards permanent runway construction almost complete
- Transition scheduled post STS-126



# **Significant Mission Firsts and Unique Items**

- Visiting Vehicle Traffic during STS-126 mated operations
  - 30P undock Nov 25. Program working on undocking 30P prior to STS-126
  - 31P launch on Nov 26, dock on Nov 30. Program working on delaying the 31P launch until after STS-126



# **Deviations, Exceedances and Anomalies**

- Information Sharing Protocol (ISP) Server Issue
  - Sluggish Lightweight Directory Access Protocol (LDAP) controller causing ISP data loss while looking for ISP servers that are not yet started.
  - Cause: In specific case, LDAP server had not been rebooted in over 150 days.
  - Workaround: LDAP controller will be part of MCC global reboots

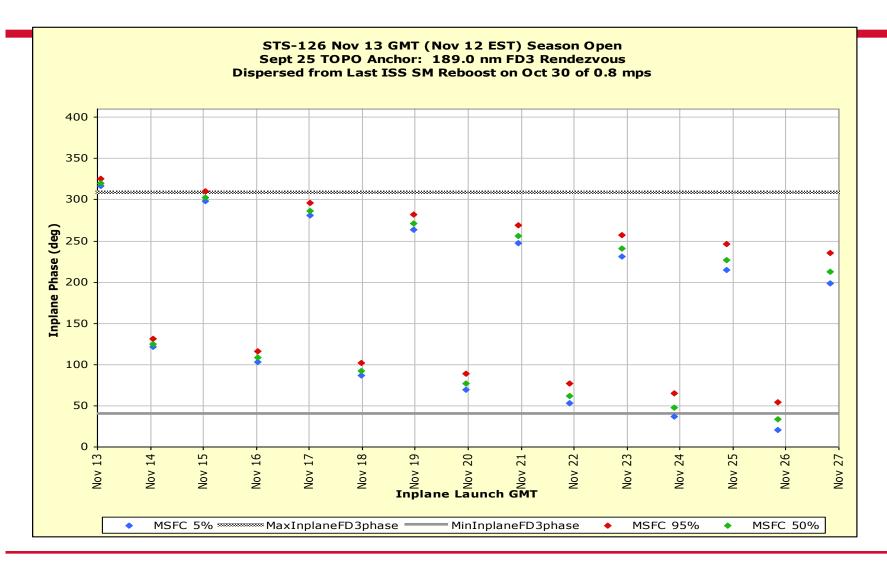
