STS-125 Launch Window and Lighting Summary

- Launch scheduled on Oct 8th at GMT 05:34:52, EDT 01:54:32
- Launch Window is ~66 minutes.
 - Preferred launch time is at the open of the launch window.
 - In-Plane launch time is ~60 minutes past window open.
 - » Ascent Performance increases for holds outside T-5 min.
- Flight Day 3 Rendezvous targeted for all launch days.
- TAL site required and Moron is the only one within cross range capability.
 - 10 second gap between RTLS Negative Return and Press to ATO boundary.
 - Moron is the only usable TAL site due to inclination.
 - » Negative Moron occurs at ~Vi=14200 fps (MET 6:00) if needed for a Systems abort.
- ECAL sites not available due to inclination.
 - Bermuda is available site for multi-failure scenarios where RTLS/TAL not available.
- MECO apogee will be ~300 nm and will be circularized by OMS2.
- ET Photography will occur in darkness
 - ET Umbilical photography will be satisfied with the umbilical flash and +X maneuver.
 - ET Handheld pitch maneuver will not be performed.

NOTES:

- 1) Launch will occur at the Window Open time.
- 2) In-Plane times provided for reference only.
- 2) Night launch Oct 5th through Oct 20th.

STS-400 Launch Window Summary

- Launch Window duration varies and is a function of Flight Day 2 rendezvous phasing.
 - Preferred launch time will target the beginning of Flight Day 2 phasing capability.
 - Will have Flight Day 3 Rendezvous capability if needed to increase the launch window duration.
- No TAL site required for STS-400
 - RTLS and Press to ATO abort boundaries overlap.
 - TAL Support team will release support after STS-125 launch
 - » DOD can respond within 4 days.
 - » NASA will respond on best effort basis.
- MECO apogee will be ~300 nm and will be circularized by OMS2.





• SSME Overboard Mixture Ratio Impacts

- SSME overboard mixture ratio has been decreasing since STS-114
 - » SSME's are consuming more fuel than intended (i.e. low mixture ratio).
- Space Shuttle Program approved MPS inventory update with a lower mixture ratio to reflect expected SSME performance (8/28/08 PRCB).
 - » Schedule did not permit change to commanded mixture ratio in the SSME controller software for STS-125.
- New mixture ratio has impacts on how much Flight Performance Reserve propellant is budgeted to protect against a low level cutoff.
 - » FPR is propellant budgeted to account for SSME dispersions (not failures).
 - » Amount of FPR for 1-sigma will change as a function of mixture ratio.
 - New mixture ratio will require more FPR per sigma.
 - » Statistical curve used to determine how much FPR for a particular mixture ratio is required.
- To be go for launch, Flight Rules require that 3 sigma FPR propellant must be maintained for nominal uphill MECO targets and ET Disposal.
- Launch window reserves include protecting for ET loading errors which will also change as a function of mixture ratio.
 - » New mixture ratio will result in an increase in reserve protected.
- Prelaunch Impacts
 - » New MPS inventory requires greater dispersion protection for launch window and FPR and results in ~1100 lbs APM impact.
 - » Current APM is ~1800 lbs and will be decreased to ~700 lbs.
 - » If actual ET propellant loading data is not available (i.e. via the PLOAD application) the no-PLOAD values need to be determined for this new mixture ratio [OPEN WORK].
- Powered Flight Impacts
 - » Abort boundaries move out accordingly due to the additional FPR required to protect for the sigma levels.
 - » Largest impact is Press boundaries which will move ~30 seconds later (greater TAL exposure).
 - » SSME performance cases are also impacted since more FPR now has to be protected for these cases (greater TAL exposure).





OI-32 FSW Issue for Single SSME

- Automated throttle-down for single SSME completion results in LOCV for certain 2-out SSME scenario's.
- Automated throttle-down can occur prior to when Ascent Guidance stops actively steering towards that altitude and planer targets for large underspeed cases.
 - » A large underspeed (>>500 fps) creates the conditions for this to occur.
 - » Altitude and planer steering are releases at MECO minus 40 seconds.
- Consequences are that Ascent Guidance misses the flight path angle target because it pitches down due to the throttle-down and can not recover prior to MECO.
- Crew procedure available to remedy this concern and involves manual throttle actions taken by the Flight Crew.
 - » Man throttles at 5% propellant remaining, minimum throttle down at 2% propellant remaining, followed by Auto throttles.
- Flight Rules and Crew procedures in place for STS-125 to alleviate this condition.

UHF Radio Squelch Issue

- Onboard squelch failed for UHF Guard frequency.
- Test during TCDT will verify good transmit/receive capability.
- Guard Frequency only used for contingency and ELS abort.

Restring/Power cycle for RNDZ

- Actions will be taken to maintain rendezvous capability with Hubble.
 - » Restring for SSME throttle capability.
 - » Power cycle one of two SSME Controllers to clear performance case.
- Lower altitudes could result in RMS loads due to mated gravity gradient attitude and resulting vehicle torques and increased turnaround for the rescue mission.





Advanced Health Management System (AHMS) Downlink

- STS-125 is first flight with new SSME controller software capability to downlink AHMS main engine controller data while on-orbit
 - » Must be performed prior to removing power from main engine controller
 - » Backup capability to post-landing MADS data retrieval
- Ascent Checklist update approved
 - » Delay main engine controller power down until 25 minutes MET
 - » Acceptable AC inverter loading for extended period of time

Edwards Temp Runway

- EDW Temp runway will be utilized if required for AOA, PLS, or EOM support.
- No issues for Heavyweight vehicle.
- Flight Rules and Crew Procedures in place addressing landing rollout.
 - » Drag Chute Pyro lifetime issue does not compromise chute deploy.
 - » Rules and procedures in place if chute deploy does not occur.
- Transition to permanent runway will not occur prior to STS-125 landing.

DOLILU Changes

- Wind pair redline updated for generic use.
 - » Current limits did not account for SRB performance and liftoff weight.
 - » Limits used to determine if non-assessed winds late in the launch count are acceptable for flight.
- Incorporated changes specific for 28.5 deg inclination.





STS-125 Entry Public Risk Assessment

- New limit for 28.5 deg inclination entry trajectories
 - » Same philosophy used for 51.6 deg inclination approaches
 - » 2300 E-06 limit envelopes all 28.5 deg KSC ascending/descending approaches.



Spaceflight Meteorology Group (SMG)

- All NWS/SMG software used to create mission critical products or required for mission support is ready for STS-125/400.
- All SMG forecasters required to support STS-125/400 meet currency requirements listed in SMG Training & Certification plan.
- SMG using alternate weather satellite data during launch operations.
 - GOES-East (75 deg) satellite scheduled for eclipse operations 10/1/08 10/18/08 (0345Z-0630Z)
 - GOES-West (135deg) imagery providing half hourly coverage during GOES-East eclipse
 - GOES-13 (105deg) backup satellite activated for operations testing through eclipse season
- Some Moron radar products remain unavailable during the Spanish Weather Service radar network modernization.
 - Moron composite reflectivity products remain unavailable in MIDDS and AWIPS
 - SMG coordinating with Spanish Weather Service (AEMET) for estimate of data availability
 - US Navy's Rota radar data also cover the Moron area and are viewable with web browser






- ISS Operations have been running on Linux since 4/11/08














Items of Interest - Minimum Duration Flight Support



- Flight Rule 125_A2 -32 <u>Minimum Duration Flight</u> states that "If an MDF is declared, the mission will continue as planned until otherwise directed by MMT"
 - Rule carryover from previous HST Servicing Missions
 - » Rationale discusses the uniqueness of the mission (last shuttle HST servicing missions) and the additional risks being accepted to continue to nominal EOM
 - » Assumes "Single fault tolerance" is retained and that the are no "generic" failure concerns
 - Philosophy similar to how ISS mission MDFs are structured
 - » Continue with mission until Cat 1 objectives complete
 - If MMT determines additional risks are not warranted and requests early mission termination, mission duration determination and number of EVAs to be re-planned will utilize the following:
 - » 125_A2-XX Servicing Mission Success Criteria (PCN-1)
 - Defines Minimal Mission and Full Mission success criteria
 - » 125_A2-36 EVA Task Replanning Guidelines
 - Re-planning guidelines based on mission priorities as well as Number of EVAs completed –vs- Number of EVAs remaining
 - Re-planning guidelines as a result of HST replacement hardware failures



Items of Interest - EVA Task Replanning Guidelines



Flight Rule 125_A2-36 EVA Task Replanning Guidelines

- Provides EVA re-planning guidelines in support of a reduced EVA capability in the scenario where the 5 planned EVAs cannot be accomplished
 - » As a result of reduced mission duration, loss of EVA time due to Focused Inspection requirements, or loss of EVA time due to problems encountered during the EVA thus losing a scheduled task
- Also provides re-planning guidelines in the event of a science instrument or battery failure (assumes nominal 5 EVAs are available)
- Pre-flight agreed to plan that minimizes "real-time" discussion and allows the next day planning process to be initiated without delay which is mandatory in support of the 5 "back-to-back" EVAs.
 - » Understanding that all failure combinations are not defined, but the basic philosophy used for the Flight Rule development can be employed/utilized for any failure scenario
 - » Philosophy:
 - Minimize changes to the planned EVAs as much as possible and focus on what can be accomplished in the nominal timeline
 - Although failures may change relative priorities, it's important to retain the big picture and utilize procedures/timelines that have been extensively choreographed, trained and have become second nature to the crew, which provides the maximum efficiency and highest probability of successfully completing all mission objectives.



Items of Interest - 125/HST SM4 EVA Glove Usage Plan

- Planned usage of Modified/Turtle Skin EMU gloves for all EVAs with the following exceptions:
 - <u>EVA 3</u>
 - » In support of ACS Task, EV1 (Grunsfeld) will wear non-modified gloves (no Overgloves during the EVA) to accomplish repair
 - Complex task requires maximum dexterity/tactile feeling
 - Poor visibility and lighting
 - Releasing and capturing a large amount of non-captive fasteners (36 fasteners)
 - Using manual screwdriver to "feel" initial release of fasteners in order not to strip them
 - Fine alignment required to not damage hardware/tools
 - Interfacing with several 1/4 turn fasteners

– <u>EVA 4</u>

- » Currently EV3 has <u>planned</u> to wear Modified/Turtle Skin gloves for the STIS repair task
 - On EVA 2, EV3 (Mass) will determine if the Modified glove will provide the required dexterity/tactile feeling to support the STIS repair task
 - If EV3 feels that the modified gloves will hinder the STIS repair efforts, he will switch to the non-modified gloves (no Overgloves) on EVA 4 to increase the probability of a successful STIS repair
 - STIS Complex task (117 fasteners) comparable to ACS repair



Items of Interest - 125/HST SM4 EVA Glove Usage Plan (cont.)

- <u>Risk Mitigation</u>
 - Exceptions identified are supported /in sync with the philosophy identified in XA-08-001 "Overglove Use Policy During US EVA"
 - » Crew in Orbiter Payload Bay
 - » New Flight Hardware
 - » Required task dexterity
 - » Etc.
 - Known "sharp edges' on HST Hardware clearly identified and warnings included in EVA procedures
 - Unknowns HST
 - » Only ~ 14% of EVA (5) time on exterior of telescope
 - » Only ~ 2.5 % of EVA (5) time on HST Handrails (MMOD)
 - EVA 3 EV1/FF ~ 8.5 ft translation on -V2 bottom handrail (see backup)
 - EVA 4 EV3/FF ~ 8.5 ft translation on -V2 bottom handrail, ~ 20 ft translation on +V3 top and right side handrail (see backup)
 - Standard glove inspections during EVA and post EVA
 - » If unexpected damage occurred, the location/cause could be quickly identified and that marked as a Warning/KOZ
 - Due to task locations, most of worksites on HST are never revisited



Items of Interest - 125/HST SM4 EVA Glove Usage Plan (cont.)

<u>Risk Mitigation (cont.)</u>

- Non-modified glove usage plan will be re-visited if continued "unexpected" damage is identified on Modified/Turtle Skin gloves that would put non-modified gloves/crew at risk
 - » Very High confidence that this won't be the case based on past HST history
- Detailed "Translation by Translation" and Task review performed at 125/HST Flight Techniques so the "community" could fully understood the HST EVA compliment and differences from ISS
 - » XA and EVA safety part of the discussions and agreements
- Plan presented at EVA CCB
 - » Chairman Concurred



Items of Interest - EV "Unable to Support" Planned EVA

- With 5 "back-to-back" EVAs it was important that we had an agreed upon plan/philosophy/guideline so we could quickly react to this scenario
- Planning Philosophy agreed upon at FTP (crew, EVA, HST, and DA8)
- EVAs will be executed in the sequence as pre-flight planned
 - <u>Pros</u>
 - » Provides highest probability of safely and successfully completing the maximum amount of mission objectives (stick to the plan)
 - EV crew members cross-trained and can be substituted to support tasks
 - Re-sequencing of EVAs results in a significant amount of inefficiencies
 - EVAs currently optimized and include planned tasks to minimize EVA duration for subsequent EVAs (PET will be longer than 6:30 if not completed)
 - You will lose a task swapping the EVA order
 - » Does not require replanning of HST Command Plan
 - Keep it simple and as planned/minimize possible mistakes
 - » Minimize EMU swaps and EVA tool reconfigurations
 - Minimize impacts to timeline
 - <u>Cons</u>
 - » "Back to Back" EVA for one EV crew



Items of Interest - EV "Unable to Support" Planned EVA (cont.)

- Plan assumes that the EV who could not support that day's EVA would recover and be able to support remainder of his planned EVAs
 - If EV unable to recover the plan would <u>still</u> be to execute the EVAs in the pre-flight sequence and:
 - » Swap out crew members to minimize "back-to-back" EVA requirements
 - » Consideration will be given to deleting an EVA and re-plan using EVA Task Replanning Guidelines
 - Dependent on crew fatigue and/or EVA Cross Training



Items of Interest - PPCO2 Management



- STS-125/HST LiOH Plan is to perform dual can change outs except Pre-sleep on FD1, FD3, FD4, FD5, FD6, FD7 and FD8 (which are single can)
 - Predicted Levels (Predictions assume 7hrs of crew exercise a day)
 - » Max Peak is 6.2 MM/HG pre-sleep on FD9
 - » Between 5 6.1 MM/HG prior to post sleep LiOH change out on FD4 FD8
 - Same protocol as performed on STS-109 where peak was 5.7 MM/Hg FD4 pre-sleep
 - Predicted level assume LiOH change out 1 Hr before Pre-sleep and 1 hour after crew wake.
- Plan is to give the crew a heads up when the PPCO2 is > 5.0 MM/Hg and give them an option to change out the LiOH at the time
 - Follows same philosophy used on STS-124
- Changes to LiOH change out plan/PPCO2 management will be determined based on actual PPCO2 levels/rates that are seen during the mission
 - Later or earlier change outs may be requested
- CDR (who was CDR on STS-109) reviewed 125 predictions and 109 actuals and is in agreement with the proposed plan



Items of Interest – Orbit Adjust for MMOD Exposure Mitigation Strategy

- Plan it to target for ~ 160NM Perigee after Late Inspection imagery review ~ 8/19:30 FD10.
 - ~ 48 hours in 308 x 160 NM Orbit prior to Deorbit
 - OA not "1 for 1" Deorbit cost due to large elliptical Orbit
- Higher priority objective is Deorbit Opportunity protection (2+2+2) which may require increasing the perigee slightly to meet the required landing opportunities
 - May not get specifically to 160 NM but any reduction in altitude decreases the MMOD probability
- Prop Priority Table (starting from 2-2-2 protection)
 - » 10. PROVIDE ADDITIONAL DEORBIT ATTEMPTS UP TO 2-2-2, INCLUDING ANY REQUIRED ORBIT ADJUST BURNS (MAY BE COMBINED WITH ORBIT ADJUST FOR MMOD)
 - » 11. ET PHOTOGRAPHY PITCH MANEUVER
 - » 12. FCS CHECKOUT WITH APU RUNNING
 - » 13. OMS ENGINE FAIL
 - » 14. ORBIT ADJUST FOR MMOD MITIGATION
 - » 15. HST REBOOST
 - » 16. SECONDARY PAYLOAD OPERATIONS
 - » 17. ADJUST ORBIT FOR ADDITIONAL LANDING OPPORTUNITIES



Items of Interest - Loss Of Ku Plan



- A Contingency Plan has been developed in support of Loss of Ku
 - Provides operations plan to support Loss of KU capabilities
 - Best effort to maximize available capability
 - Which Include:
 - » TPS Inspections
 - Record data per nominal plan (DTV Tape, IDC Laptop, Digital stills)
 - Crewmember assigned to watch LDRI/ITVC data (via monitor) and log GMT if they notice a possible defect/something off nominal in scans
 - Update TFL to support SSV during inspection activities
 - Current priority goes to HST data (since nominally KU available)
 - Utilize S-Band FM system for imagery data dumps over MILA or Dryden (possibly ESTL if ground track supports)
 - ~ 1 hr 15 minutes avail/day with MILA/Dryden
 - Highest priority goes to the areas the crew identified during the OBSS scans
 - » SSR dump management
 - » MFX/760 Activation on A/G 2
 - Limited capability
 - Does support some WLES operations



Level II Actions



• STS-124 ADI Error Needle Excursions - Closed

- During STS-124 Crew reported that the ADI needles were erratic during OMS burns in OPS 2.
- Post flight testing revealed that a OI-32 Flight Software changes to the ADI Rate switch in OPS 2 resulted in the erratic behavior.
 - » Rates changed from 10, 5, and 1 deg/sec to 5, 1, and 0.2 deg/sec respectively.
- Crew procedure change to reflect that MED (1 deg/sec) be used for OPS 2 OMS burns.
- Shuttle Program accepted this action closure.

STS-124 FCS C/O (S063871D) - Closed

- Debris noted during FCS C/O on STS-124 and Shuttle Program levied an action to determine if crew monitoring was required during this procedure.
- Integrated team comprised of applicable Program elements concluded that only benefit of crew monitoring was to determine a tile loss event.
 - » TPS PRT concluded that Tile, RCC, and Blankets are robust and we have never lost any of these components via comparison of orbit photography and postlanding assessments.
- Schedule APU operation during daylight pass and have a single crew member stationed at AFT windows during this time only.
 - » Will utilize the Nikon with 400 mm lens and have camcorder as a backup.
- Team also concluded that vehicle inspection is not required for any unidentified objects although it does not preclude using good judgment (i.e. secondary cue that something may be of concern).

• UHF Radio Criteria (S062826R2) - Open

- Shuttle Program asked MOD to construct a Flight Rule loss definition for the UHF Radio.
- Rule is complete and will be part of the STS-125 Annex, Final, PCN-1.

EVA Open Work – Flight Rule Violation

- Flight Rule A15-17 Requires that Payload Bay be configured such that an Entry is possible at the end of any EVA
- On STS-400, the rope strung along the RMS will interfere with the RMS Elbow and Wrist MPM striker bars, and cross the shoulder join, precluding stowage of the RMS as well as jettison.
- Possible solutions being considered include
 - Not using the rope at all (will add some TBD time to each translation, but tether protocols will be maintained)
 - Deconfiguring the rope at the end of each EVA, then reconfiguring again (will add approximately 30 minutes to each EVA)
 - Changing the way the rope is fairleaded to the RMS (could require re-analysis by Engineering)
 - Accepting the risk of the rope interfering with the RMS stow and jettison
 - » The failure cases that this rule protects are several levels deep
 - » If we were in this case, we would be leaving crewmembers behind on STS-125, which would be bad case as well
 - » The only case this protects for is the need for an immediate de-orbit, such as a large cabin or Prop leak.

 - » Drives new mandatory weather balloon criteria for L-2:20 hr balloon

STS-400 Launch Count Execution

- STS-125 has 25 days of CSCS capability with Group C powerdown
- STS-400 launch available at Launch + 7 days from Pad 39B
 - » STS-400 will work up to and hold at L-3 days after STS-125 launches
- Trajectory Server redundancy available for dual mission execution
 - » 4'th Trajectory Server now ready to support simulations and missions

STS-125 & STS-400 Launch Window Review

- 66 minute planar window opening on ET sideslip angle heating and closing on ET disposal
 - » No cutouts between phasing windows on 2-pane launch days
- No changes required for prelaunch conjunction screening process
 - » Expect multiple objects in screening volume





STS-125 Ascent Abort Site Review

- 1 TAL site (Moron) required to fill last RTLS/first ATO abort gap
- Contingency abort capability to Bermuda
 - » Yaw steering I-loads optimized for landing site capability and SAR force ranging
- Banjul serves as inplane ELS TAL site
 - » Selected onboard at negative MRN
- Other ELS sites available from a trajectory standpoint, but undesirable

STS-125 Entry Public Risk Assessment

- Range Safety Panel expecting new Ec limit for 28.5 deg inclination entry trajectories
 - » 2700 E-06 limit envelopes all 28.5 deg KSC ascending/descending approaches
 - » Same NASA NPR philosophy used for 51.6 deg inclination approaches (Ec = 1800 E-06)





STS-125 Recovery Prebank Assessment

- Mission-specific recovery prebank chart developed for STS-125
- Downrange redesignation changes
 - » 28.5 deg compatible downrange sites are both CONUS & ELS (Bermuda, Amilcar Cabral) sites
- Assess performing ELS redesignation at lower wing leading edge temperature limit compared to 51.6 deg missions

STS-400 RTLS Design Issues

- Lightweight, high performance characteristics of STS-400 introduces unique design considerations
- Range-Velocity MECO target redesigned with new design point to mitigate ET third peak heating concerns for late engine out conditions
- RTLS Pullout Nz target increased slightly to 2.3 g to avoid flight control instability region in Alpha Transition phase of gliding flight





- SSME Launch Commit Criteria
 - Booster group proposed modifications for 2 existing LCCs
 - » New prelaunch monitoring philosophy for main engine shutdown pushbuttons
 - OI-32 introduced new downlink parameters so pushbutton contact dilemmas can be detected in OPS-9
 - Introduce constant monitoring, instead of a one-time check, for 2 of 2 pushbutton contacts failed 'on' in OPS-1
 - » LCC for Limit switch contact failures still in work

GPS Ramp-up Summary

- GPS performance has been very good on the 6 ramp-up flights
- Nominal procedure will continue to be taking GPS in both PASS and BFS in OPS 301 prior to the deorbit burn and after high-speed C-band tracking confirms the navigation state





STS-123 Post Flight Review

- UHF performance in low power mode acceptable for launch & landing
- Nominal GPS performance (last 3-string ramp up mission)
- Launch & Landing weather balloon reliability issues observed
- Touchdown distances > 3500 ft at KSC are undesirable
- Prelaunch voice circuit issues at KSC
- Post-landing MILA configuration issues delayed handover

STS-124 Post Flight Review

- Asymmetric SRB thrust tail-off caused roll excursion at SRB separation
- Ascent FDO will characterize tracking uncertainties when performing prelaunch conjunction screening
- No glare observed by CDR, despite glare predictions
- No 'omega-bend' observed during payload bay door closing, nor during post-landing processing
- Satellite visible imagery mismatch between SMG and Flight Director workstations during 'rapid scan' operations
