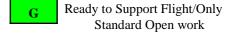

SSME Overboard Mixture Ratio Update

- Per 8/28/08 PRCB, the SSME controller commanded mixture ratio will be updated for STS-126.
- With this update, no ascent performance holdbacks are required.
- The associated MCC updates will be incorporated per the nominal processes.

OI-32 FSW Workaround for Single SSME Completion

- OI-32 introduced code to simplify crew task by automating throttle down for two out SSME scenario's but had unexpected consequences.
- LOCV for certain 2-out SSME scenarios that cause an unplanned re-entry shortly after OMS-1.
 - » Incorrect flight path angle at MECO results when Ascent Guidance continues actively steering towards the altitude planar targets after SSME throttle down.
 - » Consequence is that the OMS-1 burn occurs after the optimum apogee and reentry occurs.
- Crew procedures incorporated into FDF to remedy this concern based on A/E FTP assessment.
 - » For Single SSME scenarios the Crew will select Manual throttles at 5% propellant remaining, minimum throttles at 2% propellant remaining, followed by Auto throttles.
 - Crew and MCC have trained these.
 - » Flight Rules and Crew procedures in place for STS-126 and subs to alleviate this condition.

OI-33 RTLS ET Separation Improvements

- Several minor changes made to improve Post MECO attitude control and reduce the risk of recontact with the ET.
 - » MECO target changed from $\alpha = -2^{\circ}$ to $\alpha = 0^{\circ}$
 - » Yaw jets used to supplement roll control
 - » Control during severe roll off cases improved
 - » Rudder/Speedbrake deployed to 80.6° at MECO Confirmed



Ascent/Entry Topics (cont.)





- Impacts of UHF Radio failed power amplifier
 - Same configuration as STS-123
 - STS-123 performance and analysis demonstrate that low power configuration is sufficient for required Ascent/Entry operations.
- Edwards Temporary Runway Status
 - EDW Temp runway will be utilized if required for AOA, PLS, or EOM support.
 - No issues for Heavyweight vehicle.
 - Flight Rules and Crew Procedures in place addressing landing/rollout with and without the drag chute.
 - Transition to permanent runway will not occur prior to STS-126 landing.
- Payload Bay monitoring during FCS Checkout
 - The FCS Checkout will be scheduled during daylight.
 - A crew member will monitor the Payload Bay during FCS Checkout while the APUs are operating.
 - Any FOD identified leaving the Payload Bay will be photographed and downlinked.



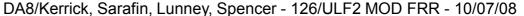
Ascent/Entry Topics (cont.)





- Unidentified Noise from ET during Stacking Operations in VAB
 - When rotating the ET to the vertical position in the VAB, several operators reported a metallic clang emanating from the ET.
 - KSC performed extensive NDE inspections of the ET but could not identify the source of the noise.
 - The IPR was closed as an UA with the most likely cause being FOD within a stringer or VAB GSE causing the noise.
 - No changes are required to current Flight Rules or procedures.
- Advanced Health Management System (AHMS) Downlink
 - STS-126/ULF2 is first flight with new SSME controller software capability to downlink AHMS main engine controller data while on-orbit
 - » Must be performed prior to removing power from main engine controller
 - » Backup capability to post-landing MADS data retrieval
 - Ascent Checklist update approved
 - » Delay main engine controller power down until 25 minutes MET
 - » Acceptable AC inverter loading for extended period of time
- Air Data Transducer Assembly (ADTA) Contamination
 - Spare Sensor Circuit Cards were inspected and observed to have contamination.
 - If the contamination is exposed to moisture, there is a failure mode that could result in a short circuit of the sensor card potentially failing an ADTA.
 - » Flight Rule A8-111 addresses actions to take if 3 or more ADTAs are failed.
 - » FCS Checkout performs self test of each ADTA
 - No changes are required to current Flight Rules or procedures

Spaceflight Meteorology Group (SMG)



- All NWS/SMG software used to create mission critical products or required for mission support is ready for STS-126.
- All SMG forecasters required to support STS-126 meet currency requirements listed in SMG Training & Certification plan.
- Some Spanish radar products remain unavailable during the Spanish Weather Service radar network modernization.
 - Composite reflectivity products remain unavailable in MIDDS and AWIPS
 - SMG coordinating with Spanish Weather Service (AEMET) for estimate of data availability
 - US Navy's Rota radar data also cover the Moron area and are viewable with web browser
- The French weather service has provided SMG access to a web site with radar, lightning and other data products that cover Istres.
 - This web site will be used to replace French radar images that were removed from the Spanish weather data server prior to STS-124.

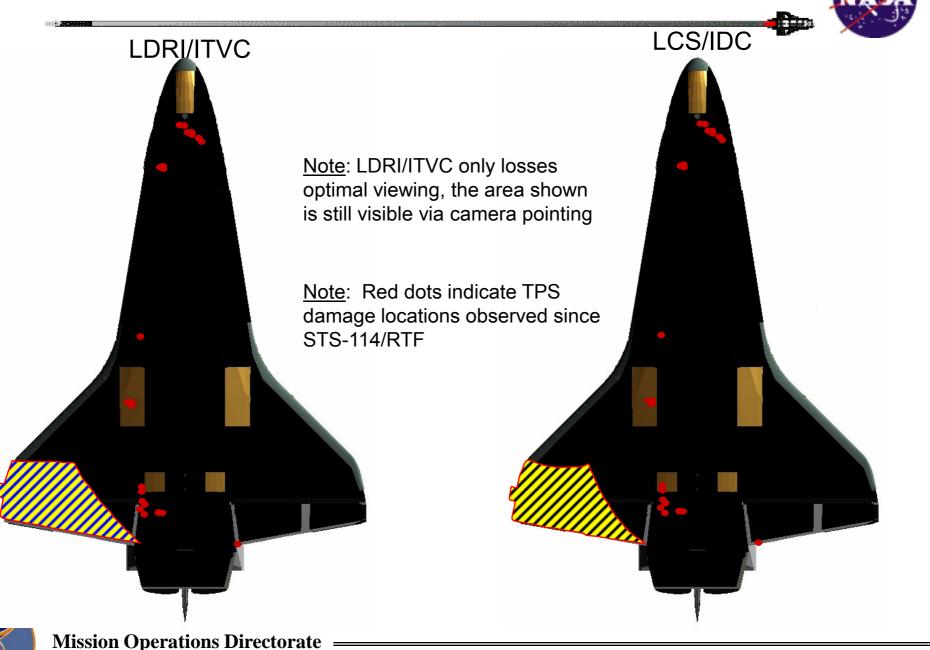


New Operations: Docked Focused Inspection

- Nominal FD2 and Late Inspection plans
 - Returning to use of generic procedures used between STS-117/13A and STS-122/1E
- Focused Inspection constraints:
 - Limited capability to perform starboard wing Focused Inspection (FI) while docked
 - » SRMS/OBSS structural interference once MPLM installed at Node 2 Nadir
 - » See next chart for affected zones on starboard wing
 - » Alternate timeline developed for starboard wingtip FI. Back up plan is to delay MPLM and EVA activities by one day each (uses +1 day on FD4):
 - FD4 Focused Inspection crew procedure review, Focused Inspection, middeck transfer
 - FD5 MPLM install and Ingress
 - FD6 EVA 1
 - OPO and DAT plan to prioritize starboard wing imagery during standard FD3 reviews
 - » Flight Control Team (FCT) will need a decision on Starboard Wing FI by start of crew sleep on FD3 (MET 002/05:00, ~23:30 CST Sunday for 11/14 launch)
 - » FCT will make a real-time call regarding MPLM Install Go/No-Go decision on FD4
 - Focused Inspection for areas <u>other</u> than area shadowed by MPLM on starboard wing will take place on FD6 (if required)
 - » Best effort will be made to perform only a single FI (on either FD4 or FD6)

New Ops: Orbiter Contamination Mitigation

- NASA
- Orbiter hardware contamination mitigation is necessary during Starboard SARJ cleaning EVA operations. Ops actions are:
 - OBSS sensor Field of View (FOV) to be pointed more than 90 degrees from view of starboard SARJ during EVA cleaning ops
 - » A dedicated SRMS maneuver is planned to impose the orbiter body on SRMS/OBSS (see back-up slide)
 - » Starboard SARJ cleaning planned for portions of EVAs 1, 2, and 3
 - » No constraints during EVA 4 (Port SARJ Lube EVA ops)
 - » OBSS will be on SRMS from FD3 (post-dock) until Late Inspection (post undock)
 - Robotic Sideview Camera (RSC) FOV to be pointed more than 90 degrees from view of starboard SARJ (also protected via dedicated SRMS maneuver)
 - Z star tracker door will be closed (already blocked by ISS structure)
 - Payload Bay cameras not being used to support Starboard SARJ cleaning ops will be pointed more than 90 degrees from FOV of Starboard SARJ
 - » Cameras B and C are planned to be used and are allowed to be pointed at Starboard SARJ during cleaning ops

New Operations: Orbit Operations



- Picosat deployment requires increased separation delta-v at undock
 - Undock & Fly-around on FD14, followed by 3 separation burns of 1.5 fps, 5.6 fps, and 5.6 fps respectively to set up safe relative distance to ISS
 - OBSS is on SRMS in undock position during this timeframe
 - Picosat Deploy occurs on FD15 (spring ejected)
 - Picosat has ability to adjust its own orbit and will do so at end of primary mission
 - » Burn is no earlier than 30 days after deploy
- O2 Cross-over Valve hardware modification:
 - O2 System 2 Cross Over Valve bypassed due to erratic performance, temporarily using MO10W valve
 - Two nominal procedures affected by hardware modification
 - » PCS reconfig actions in Post Insertion timeframe and Deorbit Prep C/L
 - Single failure deep procedures will be flown (OPCL, MAL, etc)
 - Two+ failure deep procedures will be uplinked in real time following first failure
 - » Procedures have been developed and are ready for uplink as required
- Main Landing Gear (MLG) heater DTO to validate thermal models
 - Engineering may request MOD to turn MLG heaters on for several days (4-5 days docked)
 - Cryo margins can support request and still support 15+1+2 mission duration
 - » Pad hold capability would be reduced to 125 hours
 - Ideally would gather data that may allow flying high betas without requiring PTC at EOM



New Operations: EMU Glove Plan



- The EV crew's prime gloves will be the modified TMG gloves
 - Incorporate new RTV Silicone on palm/fingers
 - Add new protective material layer on index finger and thumb
- The EV crew's backup gloves are modified EMU gloves that have TurtleSkin™ patches sewn onto the thumb and index fingers in the region of interest (same as prime gloves used on STS-124/1J)
- The same criteria applies to either type of glove
 - No requirement to wear overgloves
 - Any RTV loss will not be reason to don overgloves
 - Periodic glove inspections will occur and post-EVA glove photos will be taken and downlinked for assessment
 - EVA will be terminated for a visible cut or hole



New Operations: 6-Person Crew Hardware



- STS-126/ULF2 will bring the following 6-person crew hardware to ISS
 - Water Recovery System (WRS) Rack #1
 - WRS #2
 - Waste and Hygiene Compartment (WHC)
 - Galley (Express Rack #6)
 - Advanced Resistive Exercise Device (ARED)
 - Crew Quarters (2)
 - Total Organic Carbon Analyzer (TOCA)
 - Food Warmers
- The WRS and WHC racks will be outfitted with loose hardware also launched on STS-126/ULF2
- The Water Processor Assembly (WPA) and the Urine Processor Assembly (UPA) will be activated during the docked mission to process urine from a Russian water container (ЕДВ), return that sample for ground processing, and process an onboard sample using the TOCA

New Operations: EVA Operations



- Over the course of EVAs 1, 2, and 3, the crew will clean and lubricate the race ring, and change out 11 Trundle Bearing Assemblies (TBAs) on the Starboard SARJ
- The Port SARJ will be cleaned and lubricated as a preemptive measure to mitigate the potential for the friction-induced issues seen on the Starboard SARJ. Lubrication will be applied to 50% of the surface, relying on SARJ rotation to spread to the remaining surface.
- The positioning of both the Starboard and Port SARJs is critical to the success of the EVA choreography and cover removal plan on all EVAs and is defined in ULF2 B2-XX
 - Starboard SARJ to be at a position of 105 degrees for EVA 1 and then 60 degrees for EVAs 2 and 3. This allows for clean race ring to be rotated under the Drive Latch Assemblies (DLAs), which are not being removed for cleaning.
 - EVA 4 must start off with the Port SARJ at either 30 or 210 degrees for both applications of lubrication
- SSRMS LEE A will be lubricated to address the presence of S-curves in the snare wire and which could impede the ability to perform free-flyer captures (i.e. HTV)

New Operations: Robotics & Transfer Ops



- EVA 1 ORU (NTA/FHRC) Transfer w/ ESP-3 on MCAS:
 - To maximize the amount of EVA time available for SARJ tasks, ESP-3 (with the return NTA) will be relocated to the MT (MCAS) shortly before the STS-126/ULF2 docked mission.
- MPLM Installation
 - The SSRMS will be used to perform the first installation of MPLM to Node 2 (Nadir)
 - » Should an issue arise with a Node 2 Nadir Installation, the backup installation site will be Node 2 Zenith. Ops products will be available to support, but a standdown in MPLM install operations will be required to revise analyses.
- Transfer Operations Summary
 - MPLM Transfer is highly choreographed, including some rack transfers that are planned to occur prior to ULF2
 - » Currently carrying 85 hours of generic MPLM Transfer plus an additional 33 hours for rack and ORU transfer
 - All items required for the execution of EVA 1 have been stowed in the Middeck (ex. 4 TBAs, SARJ tools, wipes, etc.)



New Operations: MCC



- Shuttle support workstations transitioned to the Linux workstations/software
 - Workstation Install Complete:
 - » BFCR (HST Customer) 2/27/08
 - » WMPSR 7/22/08
 - » WFCR 6/27/08
 - STS-126/ULF2 Linux Cert Mode Lockdown scheduled for 10/10/08
- ISS Operations have been running on Linux since 4/11/08
- Two Linux issues have been uncovered
 - User data can go stale with no alert to the user that data is not updating (SSP & ISS)
 - » Multiple Information Sharing Protocol (ISP) Servers are taking a greater than expected amount of time to complete job of publishing data to user displays/comps/plots
 - » ISP Server data will intermittently become stale for up to 10 seconds and the user has no indications that this data is not being updated (i.e. no "s", color change, etc)
 - Frequency of occurrence varies but has been noted during A/E simulations
 - » The ISP Server recovers on its own and data flow will continue nominally
 - » Root Cause identified as a sluggish LDAP (Light Weight Directory Access Protocol) domain controller
 - Used to manage MCC and IPS account info
 - After reboot of LDAP (9/5) no problems have occurred
 - » Fix
 - Reboot of LDAPdomain controller prior to mission support (good for 1 month +)
 - MCC Global Reboot Procedure developed
 - Data is continuously monitored for reoccurrence
 - A fix will be delivered for testing in Dec, 08 and available for step up in Mar, 09
 - JMEWS (used as a strip chart replacement) has been inconsistent in plotting real-time data
 - » MMACS will retain one Unix workstation to run strip chart recorders until this issue is resolved.

STS-124/1J IFA Closure – JEM Unberth



- Y-axis oscillations observed during STS-124/1J JEM payload unberth
 - IFA written as constraint to STS-126/ULF2 MPLM unberth ops
 - FOICB (on 8/25/08) agreed to close IFA with the following rationale from MOD & SE&I:
 - » JEM payload and scuff plate design had known ICD violations that allowed reduced clearance
 - STS-126/ULF2 has no such issues
 - » Mass and diameter of MPLM is less than JEM
 - JEM had a larger moment at grapple fixture to induce cross coupling effects
 - » STS-124/1J JEM unberth command rate was much faster than previous flights unberthing heavy payloads
 - STS-126/ULF2 and future crews re-sensitized to importance of slow unberth rate command input
 - Crew robotics training modified to provide plotted performance data regarding unberth tasks, rather than previous verbal instructor feedback
 - » Unberth arm rates are limited to 0.11 fps, which is scuff plate design limit
 - No changes were made to STS-126/ULF2 MPLM unberth operations



Safety Issues

- Insufficient controls related to pretreated urine (PTU Tox 2) QDs for WRS and associated interfaces becoming sticky and failing open
 - Current design dictates only one PTU source (WHC or EDV) into the WRS, with nominal mate/demates originally planned to switch between them
 - » CR in development for Y-hose fabrication, but one year away
 - · Installation of Y-hose still requires mate/demate cycle of PTU QDs
 - Plan to proceed with ULF2 ops with no demate of this interface
 - Demate plan (short-term):
 - » Bag QD, demate & check for leakage, can unbag only if no leakage (ULF2 NCR)
 - » Boeing/MSFC Safety to provide NCR (ECD in work)
 - » Need decision on short term plan acceptability (ULF2 NCR) by ~E18 arrival
 - » DX4/OSO to verify feasibility of QD bagging technique and procedures in support of NCR (ECD in work)
 - Program Risk if leakage detected
 - Analysis to be initiated to demonstrate QD functionality in expected environment
 - » Positive results could provide sufficient rationale for long-term NCR (1FT to eye damage)
 - » OB/M.B. Edeen and MSFC Engineering to provide analysis (ECD in work)
 - » Boeing/MSFC Safety to provide NCR (ECD in work)
 - » Need decision on long term plan (with analysis) acceptability (NCR) by ~early Dec to support checkout prior to 6-person crew



Safety Issues



- Acceptability of free hygiene water in Lab from WHC and/or TeSS
 - Potential for common cause failure resulting in loss of redundant critical equipment
 - Hygiene Working Group and Boeing Safety assessing
 - Stage issue not a concern for ULF2
 - » No hygiene in WHC/TeSS until resolved
 - » Potential impact to Go/No-Go for 6-person crew operations
 - Need resolution by March '09
- Remaining open OCADs due to open Hazard Reports/NCRs considered Standard Open Work

Flight Rules



- All required generic volume A, B, C, and D flight rules have been developed, reviewed, and approved by the appropriate Flight Techniques Panels, JOPs, and the FRCB
- The following generic publications are applicable for STS-126/ULF2
 - Volume A (STS), Final, PCN-9 dated 1/22/08
 - Volume B (ISS), Final, dated 9/2/08
 - Volume C (Joint), Final, PCN-4 dated 5/5/08
 - Volume D (Soyuz/Progress), Final, PCN-5, dated 9/10/08
- STS-126/ULF2 flight rules annex
 - Final, expected approval at JPRCB on 10/6/08
 - PCN-1 targeted for JPRCB approval on 10/31/08

FDF/ODF/SODF





- DA8 has participated in FDF/ODF/SODF processes and procedure reviews as required
- FDF/ODF will be ready to support STS-126/ULF2
- New US procedures are primarily for:
 - MPLM/Node 2 Nadir vestibule outfitting, activation, ingress
 - Regen ECLSS system set-up and activation for baseline sample return and commissioning to support go for 6-person crew operations

Flight Director Mission Staffing



- All STS-126/ULF2 Flight Directors are certified per Flight Director Certification Guide (DA8-00010), Final, dated June 2, 2008
- Additional certified Flight Directors are available to support Team 4, EMCC, and STS-119/LON flight, as required
- MOD Work Guidelines are met: Due to the expected mission duration, Shuttle Orbit 2 and Planning Teams are augmented
- Flight-specific certifications are expected to be complete by October 30, 2008

EMCC/BCC



- No changes to EMCC procedures since STS-124/1J
 - Personnel are identified to support EMCC, if required
- BCC procedures were just updated to include lessons learned since 1J/STS-124 (from Hurricanes Gustav and Ike)
 - Personnel and Facilities are ready to support
 - » MSFC/HOSC certified availability



Non-Standard Open Work



- Level II (Program) Actions 126/ULF2 Flight Effectivity/Constraint
 - There are no open Space Shuttle Program Open Actions that have an STS-126/ULF2 Flight Effectivity assigned for MOD
 - There are no open Space Station Program Open Actions that have a ULF2 Flight Effectivity assigned to MOD for STS-126/ULF2
- Potential threats
 - Progress (30P) undocking during STS-126/ULF2 mission
 - » Discussion with FPWG Chair and RSC-E on 10/6
 - Progress (31P) docking during STS-126/ULF2 mission
 - » Low likelihood, but possibility

A/E FTP #231, #235, #236 & #238 Summary



- After extensive review of the current brake energy Flight Rule and procedure rationale, VMS test procedures for the proposed changes, brake energy reconstruction process and history, A/E FTP agreed to the following changes:
 - Generic braking procedure update for STS-124 and subs
 - » Braking procedure only considers 2 cues
 - Brake initiation at 5,000 ft rollout remaining or 120 knots groundspeed
 - » Clarifies when maximum braking is required
 - · Max brakes required only if groundspeed is greater than 140 knots at 5,000 ft remaining
 - Edwards temporary runway changes
 - » Brake Energy limits increased from 42M ft-lbs to 52M ft-lbs (with NWS)
 - » For heavy-weight orbiter landings, nominal braking initiation at 4,000 ft rollout remaining or 120 knots groundspeed, whichever comes first.

SSME LCC Update

 - » Instead of a one-time check, the launch team will constantly monitor pushbutton contacts down to T-31 sec for 2 of 2 pushbutton contacts failed 'on'
- LCC for Limit switch contact failures still in work

3 String GPS Ramp Up Summary

- GPS performance has been very good on the 6 ramp-up flights
- Nominal procedure will continue to be taking GPS in both PASS and BFS in OPS 301 prior to the deorbit burn and after high-speed C-band tracking confirms the navigation state

DOLILU Wind Change Redline

- Wind pair redline updated for generic use
 - » Current limits did not account for SRB performance and liftoff weight.
 - » Limits used to determine if non-assessed winds late in the launch count are acceptable for flight.

I/O Reset Considerations

- Current procedures allow crew to execute an I/O Reset for a bypassed LRU
- If a non-universal I/O error caused the bypass, executing a GNC I/O RESET could cause a redundant set split as recently witnessed during troubleshooting of the MDM FA2 anomaly prior to STS-124.
- In order to mitigate the possibility of the set split during dynamic flight, crew procedures have been updated to have the crew check with MCC prior to executing the I/O RESET.
 - » MCC has more insight to the bypassed LRU and can quickly determine if a non-universal I/O error is present.
 - » If no comm is available with the ground, per established protocol, the crew may execute the I/O RESET if required.
 - » GNC I/O RESETs imbedded in nominal procedures do not require the MCC check.

ESP-3 on MCAS Option for EVA 1

 Reviewed 3 different methods for performing ORU transfers on EVA1. Selected the option of relocating ESP-3 to the MCAS on the MT prior to the mission in an effort to minimize the amount of EVA time required for ORU transfer, allowing more time for SARJ activities

Docked Focused Inspection

Optimal Scan (5 ft normal to surface ±15°)

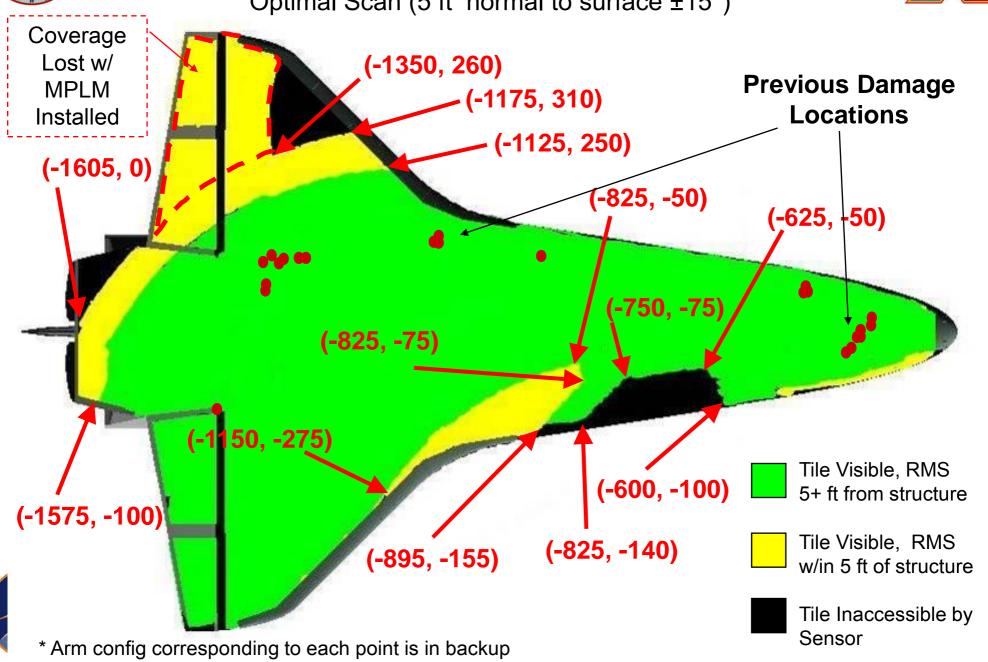
