Subject: STS-128/17A Mated Shuttle/ISS Operations DAP Modes and Constraints, Revision A

Revision A

This revision updates the results in Sections 5 through 7 based on the attitudes in the July 22, 2009 Final ATL, including propellant and ΔV estimates for mission-specific maneuvers and attitude holds. A comment about the increased rate limit was added to the the Summary Section for the mated APU fuel dump scenario. A subsection was added in Section 3 to describe analysis to certify Orbiter attitude control during the N₂ vent for ATA replacement.

Summary

This memo provides a summary of the shuttle flight control parameters, I-Loads, control modes, jet tables, constraints, and recommendations for STS-128 mated Orbiter/ISS and unmated Orbiter Boom Sensor System (OBSS) operations. The DAP modes and constraints listed here are based on the STS-128 flight I-Loads defined in [1, 2].

The primary objective of the STS-128/17A mission is to deliver and retrieve cargo using the Multi-Purpose Logistics Module (MPLM) and to replace an Ammonia Tank Assembly (ATA). The MPLM will be installed onto the nadir Common Berthing Mechanism (CBM) port on Node2 using the Space Station Remote Manipulator System (SSRMS) early in the mission. Then, various items will be taken from or placed into the MPLM before it is returned to the Orbiter payload bay before undocking.

Visiting Vehicles and Mass Properties Due to variability in the launch schedules, there is uncertainty regarding which vehicles will be docked at the nadir DC1 (Docking Compartment-1) port and the aft SM (Service Module) port on the ISS. There must always be at least 1 Soyuz available for crew return for a 3-person crew, and 2 Soyuz for a 6-person crew. The current schedule has a 6-person crew at the time of STS-128. As a result, only those configurations with two or more Russian Vehicles docked are considered. A launch delay of 1-5 weeks could result in the presence of the Japanese HTV1 (H-II Transfer Vehicle 1) spacecraft at the zenith CBM of Node2. A launch delay of 3 months could introduce the Russian Mini Research Module (MRM2), a fourth Russian vehicle docking port located on the zenith of the SM. From a mass property standpoint, the STS-128 I-Loads are acceptable with either HTV1 or MRM2.

There are currently 3 primary docking ports to which support vehicles may dock. Table 1 shows the 3 ports, listed in order from fore to aft, with typical occupants for each port.

A vehicle swap at the SM aft port causes signicant changes in the mated mass properties – sufficient to require distinct mass property I-Loads. The exception is a swap of Soyuz and Progress vehicles, which have very similar mass properties. The other two ports are located farther forward, closer to the composite center-of-mass. A vehicle change at either or both of these ports (FGB nadir and DC1 nadir) may affect performance, but does not usually require distinct mass property I-Load sets.

Since ATV-2 is not scheduled until 2010, Progress and Soyuz spacecraft are the only docked support vehicles expected during STS-128. Consequently, separate mass property I-Loads sets were defined for two different SM aft vehicle possibilities – no vehicle or a Russian vehicle (Progress or Soyuz). Variations at the other two ports were analyzed to ensure adequate performance. To designate the visiting-vehicle variants, a shorthand is used within this document – a 3-letter abbreviation in which the character position represents a docking port, and the initial letter of the vehicle denotes the attached vehicle. The letter "x" designates an empty port. The presence of HTV1 is indicated by an "HTV" after the 3-letter shorthand. Table 2 shows the visiting-vehicle combinations analyzed for flight certification.

Most of the analysis details shown in this memorandum are for RRR and RRR HTV since these are the most likely configurations. Summary information is provided for the other configurations. All six have been analyzed and certified for flight; detailed information is available on request. No configuration with MRM2 docked has been certified for STS-128.

Non-RMS Flex Models and Mass Properties All analysis was performed using flex models of the mated stack delivered by Jacobs Technology [13] paired with the appropriate rigid body mass properties from CAMMP (Revision AC) [14]. Table 3 describes the model nomenclature used in this document in terms of the flex models and rigid mass properties used for simulation. Since both the initial and final configurations have the MPLM berthed in the Shuttle payload bay, separate flex models were not needed.

Jet Modes As with past flights, both VRCS and ALT mode capabilities are provided. Maneuver and attitude hold capabilities are available with VRCS. Attitude hold is available with ALT, but maneuvers are *not* certified with ALT. VRCS control is available for all of the expected STS-128 configurations, including the robotics operations. ALT mode control, on the other hand, has only been certified for attitude hold, and only for the non-robotics portion of the mated flight (see Section 2). The ALT control mode is the same as for the previous mission: 1 jet, with a 7.04 second delay between firings. Since the installation of the S6 truss segment during the STS-119 mission, the control authority with 1-jet ALT mode has deteriorated to the extent that ALT should not be used for attitude maneuvers.

Robotics There are four MPLM SSRMS positions for STS-128, which are used for both MPLM installation and return. Describing function analysis and time domain simulations have been used to certify Orbiter DAP control during these loaded RMS operations (see Section 4). There are also robotics operations during the ATA replacement. At any given time, there will be up to 2 ATAs (one empty and one full) and an EVA astronaut on the SSRMS simultaneously. For the ATA operation, the SSRMS is considered unloaded from an on-orbit flight control perspective.

Reboost Two reboost options are provided for mated flight. The VRCS reboost option is the prime option for STS-128/17A. An ALT PRCS reboost method is provided for the contingency event of the loss of VRCS. The ALT mode reboost is a -Z translation which mimics the VRCS reboost; it was first incorporated into the I-Loads for STS-123 (see Section 5).

Contingency Analysis In addition to the Shuttle control capability designed for nominal operations, limited control capabilities using VRCS were developed for the APU fuel dump scenario. During the APU fuel dump scenario, the desire is to run the APUs at high power (91 hp) to burn off the APU fuel as quickly as possible. An increased rate limit of 0.05°/sec is required during a mated APU fuel dump scenario for STS-128 to avoid violations of the quarter-drift channel criterion; this is the rate limit that was analyzed for this scenario on previous missions.

Deadband Collapse Deadband collapse for direct handover to ISS CMG or USTO control has not been analyzed for STS-128/17A.

1 Configuration Specific I-Loads for STS-128/17A

I-Loads specific to the mated Orbiter and ISS are required in order for the Orbiter to provide attitude control for the stack. In particular, mass property I-Loads (containing the composite mass properties of the stack) and notch filters (ensuring stability in the presence of flexible body dynamics) must be provided for each Orbiter/ISS mated flight. This section documents the DAP I-Loads for STS-128/17A. Section 1.1 summarizes the DAP I-Load selections for STS-128/17A. Section 1.2 summarizes the I-Load changes needed to support ISS flights in general.

1.1 STS-128/17A Flight Specific I-Load Selections

Table 4 summarizes the STS-128/17A flight specific I-Load selections. OAD 0.01 contains the default occurrences for OI-34 [2]. Of the nine OA categories, one is reserved for non-mated, Orbiteralone operations, and two are reserved for STS-128/17A mated operations (see Section 2). OA1 is reserved for non-mated OBSS inspection, OA2 is reserved for mated flight while the SM aft port is empty, and OA4 is reserved for mated flight if the SM aft port is occupied by a Russian visiting vehicle (Soyuz or Progress). The RBS occurrence contains the mission specific I-Loads used for Auto Reboost of the mated configuration. The reboost design for this flight uses the same occurrence as on STS-119 through STS-127, which was based on the STS-123 design with the addition of a configuration for Orbiter jettison. The OSE, OVJ, and ZSP categories pertain to the entire flight. The relevant details of each of the I-Load categories are given in subsequent sections.

1.2 General I-Load Changes to Support ISS Flights

Table 5 summarizes the values in the OSE, ZSP, and OVJ I-Load categories currently used to support mated Shuttle/ISS operations. In the OSE category, the Unique_Filter_Selection_Value is set equal to 2 to utilize the unique filter gains (VRCS) for all payload extended configurations other than OBSS operations. For STS-120 and subsequent ISS assembly flights, the state estimator gains were redesigned in order to provide additional attenuation beyond that of past default state estimator gains [5], thereby improving overall stability with the mated stack. The new gains also help minimize a phenomenon known as "switch-line bouncing", where flex dynamics can cause the state to bounce back and forth across phase plane switching lines. This "bouncing" can cause jet toggling and has been shown to increase loads and the flex response at the IMU.

The ZSP category values are the OI-34 defaults. The value of the maneuver threshold, KH, is 4; maneuvers will only be triggered if the maneuver angle is four times the deadband. This setting is chosen to minimize maneuver cycling. The S5 scale factor is 0.2 in order to maximize phase plane drift channel height, which is desired for stability reasons. CNTR_MIN and CNTR_MAX retain the values established for STS-123 to prevent shelf-pulsing from tuning into one or more flex modes of the mated stack.

In the OVJ category, the values for Candidate_Vern_Threshold and the Candidate_Alt_Threshold are the same as the values used in all ISS assembly flights in recent years. They are set to minimize shelf-pulsing as much as possible while still maintaining acceptable performance. Since the Candidate_Vern_Threshold is quite a bit different from the nominal Orbiter-alone value, the Min_Angle_Jet_Select_Value has been set equal to 2 to remove the dependency of Orbiter-alone VRCS performance on the Candidate_Vern_Threshold. The value for Jet_Mag_Threshold(2) is 0.27, which has been utilized on past ISS assembly missions, and is needed to ensure proper selection of \pm pitch jet pairs.

2 STS-128 Mated Flight, General Strategy, and OAs

2.1 STS-128 Jet Modes for Mated Flight

The standard two jet modes, VRCS and ALT, have been certified for use during mated operations on STS-128. Both VRCS and ALT are certified for attitude hold and reboost. However, only VRCS is certified for attitude maneuvers. The use of ALT mode for maneuvers is not certified due to poor performance (a higher rate of occurrence of maneuver chasing). Attitude holds and maneuvers during robotics operations are certified for VRCS only. For purposes of this memo, the OBSS on either the SRMS or SSRMS may be considered as part of the non-robotics operations *during mated operations*. The required ALT mode and VRCS settings are given in tables throughout this document. Any values of deadbands, maneuver rates, or ALT delays other than those shown in this memo are not allowed without prior analysis by EG and ES to ensure that all ICD [6] and SODB [7] constraints are met. Failure to abide by these settings and constraints may lead to SODB violations, loads exceedances, or other undesirable consequences.

The ALT mode configuration is LowZ with X jets enabled and the forward Y jets (Groups 2 & 3) deselected. For the sake of brevity, this mode will be referred to here as ALT LowZ \pm X NFY to signify the use of the X jets and the deselection of Groups 2 & 3 (NFY: No Forward Y-jets). The deselection of Groups 2 & 3 is required to avoid plume impingement on the outboard solar arrays. The X jets option is required for pitch control during attitude hold. For reboost, however, the X jets option must be disabled. ALT mode is restricted to 1 jet on STS-128/17A. For attitude hold and reboosts, the ALT delay time is 7.04 seconds.

2.2 OA Strategy

The general OA strategy for STS-128 consists of one set of mass properties and one set of notch filters [8] for the entire mated mission for a specific aft vehicle. Due to launch schedule uncertainties, two scenarios were considered concerning the SM aft docking port on the ISS — it may be empty, or it may have a Progress/Soyuz docked. The mass properties of the mated stack for these two scenarios are significantly different from each other; thus two separate groups of I-load mass properties are required to cover the two potential stack configurations. A single OA is needed for STS-128 for all mated operations for a given Russian visiting vehicle scenario. The same notch filter set is in both OAs. This OA strategy is summarized in Table 6.

The non-RMS mated notch filter set from STS-119 is sufficient for all stages of STS-128 mated flight. It has 4 notches near 0.1Hz and two notches near 0.3Hz designed to attenuate the flex oscillation of the ODS and ISS truss modes. This notch filter set is in all mated OA slots.

Category OA1 is provided for Orbiter-alone inspection operations with the OBSS on the Shuttle RMS (SRMS). OA1 is designed to minimize the errors in the DAP's angular increments due to inertia errors in the Orbiter-alone mass property I-Loads. The goal is to keep oscillations of the OBSS/RMS to a minimum during data acquisition.

Categories OA2 and OA4 are for mated operations. These I-Load occurrences are carried over from the STS-127/2JA mission. Therefore, the I-Load titles reflect the original flight for which they were defined. Both of these mated OA categories were designed for a pressurized ODS. These mated OAs have not been certified against the non-linear effects present with an unpressurized ODS (freeplay). Robotics operations have only been certified for VRCS control, and only at the specified way points (see Section 4 for details). See Section 5 for details on the reboost performance and certification. See Section 6 for details on attitude maneuver performance and certification. See Section 7 for details on attitude hold performance and certification.

2.3 Jet and DAP Tables

A summary of the recommended mated DAP settings are shown in Table 7. The DAP tables and jet tables associated with each OA are given in Tables 8 through 16. Table 8 has the I-Loads for the OBSS operations, for reference. Tables 9 through 16 contain the DAPs and jet tables for the mated operations.

2.4 General Recommendations

2.4.1 Mission-Specific Recommendations for STS-128

• CMG Gimbal Positioning During Orbiter Control

Station CMGs should not be repositioned during reboost or during attitude maneuvers. The end of a maneuver should be understood to be when the attitude rates are damped, not when the magnitude of the attitude error is within the attitude deadband.

• CMGs in Inertial-Drift Mode During Orbiter Control

The CMGs should be in Inertial-Drift mode during long-term Orbiter control. Otherwise, the CMGs will impart a disturbance to Orbiter control which will invalidate predictions regarding Orbiter performance and control authority.

• Attitude Maneuver and Attitude Hold DAP Settings

The maneuver DAP settings should be selected when performing maneuvers. The hold DAP settings will provide improved performance for attitude hold. The only time the VRCS attitude hold DAP settings are required is at undocking, where they are necessary to satisfy the undocking attitude and rate error requirements.

• PRCS Reboost Performance

No mated reboost is scheduled for the STS-128 mission. If a reboost is required after a VRCS failure (for a collision avoidance reboost, for example), the 1-jet PRCS reboost capability is available. However, if ISS thrusters are available, we recommend the use of an ISS attitude control system to maneuver to the reboost attitude (if a maneuver is required).

2.4.2 Other Recommendations

• Deselection of IMU

Recommend deselection of an IMU during mated attitude control to avoid IMU ID switching. IMU ID switching can produce undesirable transients that result in increased propellant usage, as was observed during mated Mir operations.

• -7.5 Elevon Park

Recommend parking the elevons at -7.5 to minimize VRCS plume impingement. This is especially important for maximizing reboost efficiency.

• Downlist the Undesired Control Accels

As was requested for previous ISS assembly flights, the undesired accels should be downlisted to aid assessment of any control problems that might occur during STS-128.

• Pressurized ODS Required for Mated Flight Control

ODS pressure must be greater than 3.45 psi to avoid nonlinear dynamics at the ODS.

• Loss of Any VRCS Thruster Prohibits Use of Mated VRCS Control

Loss of any VRCS thruster will result in loss of mated vehicle VRCS control capability. The back-up control mode must be selected as soon as possible.

• Select FREE Prior to Changing Control Accel Values

When moding between control accels (OAs) that have different notch filters, FREE should be selected prior to entering the new control accel value and maintained for 30 seconds after the execution of the new value. This procedure allows any rate and acceleration estimate transients resulting from the notch update to settle prior to engaging control. All of the mated OAs for STS-128 have the same notches.

• When Moding from FREE to Shuttle Control, Mode to LVLH (INRTL) prior to AUTO

When moding from FREE to shuttle control, LVLH (INRTL) should be selected prior to moding to AUTO to sufficiently damp rates. LVLH should be selected if the subsequent maneuver is to an LVLH attitude; INTRL should be selected if the maneuver is to an inertially referenced attitude. The manual LVLH(INRTL) mode should be maintained long enough for DAP rates to stabilize to the desired rate.

• Mode through FREE when transitioning from LVLH to AUTO

Anytime AUTO control is required following a period of LVLH hold, the DAP should be moded to FREE for at least 2 seconds before selecting AUTO. This procedure is required to prevent the DAP from using a stale time reference (the time LVLH was entered) in the calculation of the initial attitude bias at auto maneuver start.

• After GPC Reset, Stay in FREE Until Undesired Accels Values are Less than 1/2 the Control Acceleration before Going to Shuttle Control

During a GPC set contraction or expansion, the GPCs are reset and the DAP is re-initialized. This produces a temporary transient in the Undesired Accels until the state estimator converges. To avoid the impact from the transient, the Undesired Accels in each of the three axes should be monitored and the DAP should stay in FREE until the Undesired Accel in each axis goes below 1/2 the respective effective MCA for that axis. See Table 17 for these values and Section 3 for a more in-depth explanation.

• Proper Control Authority Must be Maintained During Propulsive Venting Propulsive venting results in a disturbance upon the vehicle that must be countered by the jets. Under most shuttle alone conditions, the jets have more than sufficient control authority to overcome any vent disturbance. However, while mated to the ISS, constraints and limitations on Orbiter jets may result in the DAP being unable to fully oppose a venting disturbance. For full details see Section 3.

3 Control Authority and Undesired Accels

For the Orbiter to provide effective control of the mated stack, the control acceleration must always exceed the disturbance acceleration. If the disturbance acceleration is greater than the control acceleration, then the autopilot will not be able to maintain attitude control within the prescribed rate limits and deadbands. Under most circumstances the acceleration available from the jets is quite large compared to any likely disturbance acceleration. However, with the ISS as a payload there are scenarios for which the disturbance acceleration can approach or exceed the available control authority. If this occurs during a flight, then there is a risk of temporary loss of attitude control. Such a scenario can be avoided by noting the control authority the DAP has versus the expected disturbance acceleration.

The DAP estimates the available control authority from the jets via the on-board I-Load calculation. This estimate is referred to as the MCA (Magnitude of Control Acceleration). These values represent a best estimate of the single-axis acceleration available to the DAP and are used to determine when and how long to fire jets. Values of the MCAs for STS-128/17A are given in Table 17. Note that the values for ALT were adjusted to reflect the reduced control authority resulting from the ALT delay and on-time restrictions.

Disturbances on the vehicle are measured by the DAP via the state estimator. Taking the IMU increments and running the measurements through a Kalman filter results in estimates of the body rates and any disturbances due to unmodeled accelerations. These disturbances are referred to as the Undesired Accels. The DAP takes these into account in order to control the vehicle by computing the effective control authority it has available. The effective control authority available is computed by the DAP as the difference between the acceleration available from the jets (the MCAs) less the disturbance acceleration (Undesired Accels). As the effective control authority shrinks, control becomes increasingly worse. Should the effective control authority become zero or negative, then control is physically impossible.

There are two primary scenarios of note on STS-128/17A where the effective control authority can approach zero or even go negative. The first scenario is when the GPCs are reset. The reset causes the re-initialization of the DAP and a subsequent transient in the Undesired Accel values due to the re-initialization of the state estimator. The second scenario concerns venting. The resulting disturbances from some vents, in particular the propulsive vents associated with the Orbiter airlock and the APU, can exceed the control authority of some of the control modes for ISS assembly. In these scenarios there is a risk of loss of attitude control if an inappropriate control mode is selected

during venting. Such a loss of control can result in serious consequences depending upon the causes and duration. Other scenarios probably exist where the effective control authority can approach zero or even go negative, so it should be kept in mind that the GPC and venting scenarios do not constitute a complete list.

3.1 GPC Set Contraction

During GPC set contraction, the GPCs are reset and the DAP is re-initialized. This procedure re-initializes the state estimator setting the body rates and accelerations to zero. This reset results in a temporary transient in the Undesired Accels that lasts for approximately 300 seconds until the state estimator can converge on the correct rates and disturbance accelerations. During part of this period, the Undesired Accels will almost assuredly exceed the MCA values. This problem can be managed by staying in free drift until the Undesired Accel values in the downlist are less than half the available control acceleration (see Table 17). Failure to observe this procedure may cause temporary loss of control, extra jet firings, and wasted propellant.




Figure 1: Example of Undesired Accel Transients During GPC Set Contraction

Figure 1 shows an example of the effect GPC set contraction can have on the Undesired Accels. During STS-126, a GPC set contraction was performed in the middle of the post-docking maneuver. The actual rate did not change during the reset, but the filter required time for the rate estimate to converge (top plot). The spike in the roll Undesired Accel is shown in the lower plot. The state estimator required about 3 minutes (in this example) for the undesired acceleration to reach the half-MCA mark. This is not a problem if adequate time is allowed for the rate estimate to converge, as on STS-126.

3.2 Propulsive Venting

There are several sources of propulsive venting on the mated stack. The usual water dump and FES vent disturbances are small and not an issue for shuttle control. However, there are two main sources of propulsive venting that are of particular concern, and known scenarios exist where these vents may be activated. The first case involves the venting of the ODS and the second case involves APU venting.

In any venting scenario, the available control acceleration must exceed the disturbance acceleration due to venting. Since the DAP will respond to multi-axis commands, and thus the effective control acceleration may be less than the single-axis control acceleration shown in Table 17, the rule of thumb to apply is that the control acceleration should exceed the venting disturbance acceleration by a factor of 2 or more.

3.2.1 Airlock Venting

Nominal venting through the ODS/external airlock depressurization vents results in a near nonpropulsive venting of the airlock and is not a concern. However, certain airlock vents on the Orbiter can put a considerable disturbance on the mated stack. Past analyses have shown that under certain scenarios these vents can exceed the DAP's control authority for some jet modes. Should any of these venting scenarios occur, care must be taken to ensure the DAP has adequate control authority to oppose the vent force.

The vents of concern are the three hatch equalization values (HEV): the External Airlock Aft HEV, the ODS Upper HEV, and the Spacehab Tunnel Adaptor HEV. Each of these values may be operated in one of two modes, normal and emergency. Emergency mode corresponds to a larger effective value radius, higher flow rate, and therefore greater propulsive force than normal mode.

Venting through the ODS Upper HEV and the Spacehab Tunnel Adaptor HEV are well under the half MCA criteria in all three axes for all jet control modes. Thus there is no concern in using either ALT or VRCS to control during venting of the ODS Upper HEV or the Spacehab Tunnel Adaptor.

However, emergency mode venting from the External Airlock Aft HEV at an initial airlock pressure of 14.7 psi produces disturbance accelerations in pitch that are significant compared to the MCAs. Worst-case disturbance accelerations are greater than 1/2 the MCA for both ALT and VRCS mode. VRCS mode has sufficient control authority in the normal vent mode, while ALT mode does not. Therefore, propulsive venting from the External Airlock Aft HEV during mated Orbiter/ISS operations is only permitted with VRCS control and in normal vent mode. Emergency mode may be permissible if the airlock is first depressurized to an acceptable level using the normal vent mode.

3.2.2 APU Fuel Dump

In the event that an APU fuel leak is discovered, the procedure is to burn off APU fuel as quickly as possible to prevent contamination of the aft section of the Orbiter. To accomplish this goal the APU is run at high horsepower and the WSB (Water Spray Boiler) is expected to come on. Complete fuel burn-off is expected to take approximately 55 minutes. A limited capability for Orbiter control has been developed for this contingency.




Figure 2: APU Vent Force Time History

Tables 18 and 19 give the location of the relevant vents. Figure 2 shows the vent force as a function of time. The APU vent force is not a constant over time, but varies from a peak near 30 lbs to a low of zero. The horsepower setting determines the cycling of the vent and ultimately the average vent force. The average thrust is close to 14 lbs. Added to this is the WSB, which contributes a thrust of approximately 3 lbs, for a total thrust of approximately 17 lbs.

The timeline for the APU fuel dump, shown in Table 20, includes the FCS Checkout as well as the other changes to the procedure [9] made for STS-124 and subsequent flights. The vent force is about 65% of the available VRCS control force. The resulting disturbance acceleration is approximately $0.0006^{\circ}/\text{sec}^2$. Comparison to Table 17 shows that this disturbance exceeds the MCA for ALT mode, and thus ALT mode control during APU fuel dumps is not an option. The disturbance also exceeds the 1/2 MCA limit for VRCS, and thus at best the DAP will only marginally be able to handle the APU fuel dump scenario.

For each TEA in the April 20, 2009 Basic ATL, 100 Monte Carlo cases were run using the VRCS maneuver DAP with a modified rate limit of 0.05 deg/sec and using the APU thrust profile for the APU fuel dump scenario of Figure 2. Mass property dispersions of $\pm 1\%$ in inertia and ± 6 inches in center of mass, initial rate error dispersions of ± 0.01 deg/sec, and modal uncertainties of $\pm 4dB$ in amplitude and $\pm 20\%$ in frequency were applied to each of the cases. The dominating disturbance

of the dump, the vent force, has roughly the same moment arm as the VRCS jets fired by the DAP to counteract the disturbance. As a result, the expected propellant cost can be estimated by multiplying the ratio of the vent force to the VRCS jet force by the vernier jet flow rate and the length of the dump in seconds.

 $PropCost = APUVentForce/VernierJetForce \times VernierFuelFlowRate \times \#Jets \times Time$ (1)

The two down-firing vernier jets have a net force (i.e. less self-impingement) of approximately 13 lbs each, for a total of 26 lbs. Vernier flow rates are 0.091 lbs/sec/jet, and there are two jets. Thus an average APU vent force of 17 lbs for a dump of approximately 3300 seconds yields a ballpark estimate of 393 lbs. Table 21 summarizes the observed propellant usages for the APU fuel dump scenario. The Orbiter body attitude relative to LVLH expressed by a PYR Euler angle sequence is given in RPY order. Table 22 summarizes the jet firing statistics for the APU fuel dump. All of the SODB jet firing constraints are met.

Simulation results show that the DAP was able to maintain a reasonable level of attitude control throughout the 91 hp APU fuel dump for all of the configurations examined. Some runs did show transient attitude divergences outside the DAP's attitude deadband. However, in all cases the divergence was a temporary event. Given the serious nature of the contingency and threat to crew safety if a dump were not performed, these attitude divergences are not sufficiently bad nor pervasive enough to disallow the procedure.

From a flight control perspective, nothing appeared in the Monte Carlo runs that would indicate that the DAP could not handle the 91 hp APU fuel leak scenario during nominal attitude hold near the TEA. Given the nature of the disturbance, it is crucial that other technical areas, such as ER for the robotics cases and ES for loads analysis, would need to concur before such a scenario could be approved. However, from an FCS standpoint, the scenario has been demonstrated to work when the attitude is near the TEA.

3.2.3 N₂ Vent for ATA Replacement




Figure 3: N_2 Venting Thrust Profile

During STS-128, the P1 Ammonia Tank Assembly (ATA) will be replaced. As part of that procedure, it will be necessary to vent gaseous nitrogen from 2 tanks. The nominal procedure will be to issue ground commands for venting through a non-propulsive T-vent. If that fails, an EVA will be required, and the venting will be achieved through the use of a vent tool. Venting through the vent tool is propulsive, and the thrust direction is uncertain. Figure 3 is an example showing the thrust profile [10] and the resultant moments when the vent-force is in the +Z direction (Orbiter Body Axis System).

If the T-vent is used, the primary expected source of attitude disturbance is from impingement of the expelled gas onto the surrounding truss structure. Data for the direction and magnitude of this disturbance is not available, but it is safe to assume that this disturbance would be of smaller magnitude than an unperturbed vent from the vent tool. Therefore it is sufficient to show that the control system can control during a worst case disturbance from the vent tool.




Figure 4: Vent Simulation Summary

A series of VRCS attitude-hold simulations were run at the mated TEA, for a duration of 1 hour. The vehicle configuration is the Intermediate1 (post MPLM installation) phase. The vent disturbance begins at 100 seconds, and is over within about 6 minutes. The thrust was modeled in the plus and minus X, Y, and Z (Orbiter Body System) directions. The two worst case axes were also run with a doubled force magnitude. Figure 4 shows selected performance parameters from the simulations.

The simulations used the Attitude-hold DAP, with attitude deadband of 1° and rate deadband of 0.02° /second. None of the simulations, including the the double-amplitude cases, had attitude or rate error excursions outside the phase plane. None had undesired acceleration magnitudes which exceeded half the relevant mag_control_accel values (Table 17 at the top of this section).

The Orbiter control is capable of maintaining attitude during the N_2 venting for STS-128. Since the results presented here represent a worst case analysis, as opposed to an assessment of an actual predicted disturbance, and because only a limited number of cases was run, the propellant data should not be assumed to be an accurate predictor of performance during the venting.

4 Robotics Operations

4.1 Overview

The Space Station RMS (SSRMS) is used for all major robotics operations on STS-128. The SSRMS is based on the Node 2 PDGF for the unberth of the MPLM from the Payload Bay, installation to the Node 2 nadir CBM and return to the Payload Bay.

Shuttle control during loaded robotics operations is only allowed when the SSRMS is at one of the RMS positions [11] shown in Table 23 with either the brakes on or while in position hold mode. The greyed out lines in Table 23 indicate that DAP control is not allowed due to the RMS payload being too close to either the Shuttle or ISS. Only the VRCS maneuver DAP settings (A12) shown in Table 7 are allowed for the robotics operations. Shuttle control is not permitted at any time while the SSRMS is in motion and loaded with the MPLM.

During the EVA portion of the ATA SSRMS operations, the total mass on the SSRMS will remain less than 4,000 lbm. There is no generic SSRMS stability envelope, but based on engineering judgement and prior experience, we are considering all ATA operations as an unloaded arm for flight control purposes.

4.2 RMS Operations — DAP Constraints

- All non-RMS mated DAP constraints apply during loaded RMS operations.
- For loaded SSRMS operations, closed-loop DAP control is only allowed for the SSRMS positions in Table 23 using the standard mated maneuver VRCS DAP settings (A12) (see Table 7) with the SSRMS either with brakes on or in position hold mode.
- The following operations are not analyzed from an Orbiter flight control perspective during loaded SRMS, SSRMS, or JRMS operations, and are therefore not allowed:
 - ALT mode attitude control
 - Reboost (VRCS or ALT mode)
 - Propulsive venting through any of the Orbiter airlock hatch equalization valves
 - Propulsive venting for an APU fuel dump

5 Reboost

The reboost configurations for STS-128 were used previously for STS-126 and subsequent flights. For STS-128, there is one change to the settings – a rate deadband of 0.02° /sec is required for the PRCS reboost.

There are only two distinct mated reboost modes — the standard VRCS and PRCS reboost modes from past flights. Configuration 1 is the only PRCS mated reboost, and is only to be used as backup due to reduced control authority with ALT. Configurations 3 and 4 contain identical I-Loads for VRCS reboost. Both mated reboost modes can be used to perform a deboost by using a different attitude. Configuration 2 is for contingency jettison of an un-crewed Orbiter and *is not certified for mated reboost*.

Table 24 outlines the basic mated reboost designs for STS-128. The related information for the non-mated reboost is shown in Table 25.

The DAP configuration for the unmanned Orbiter Separation and Disposal Procedure is defined in [12]. Note that many of the comments and constraints in this document regarding mated reboost do not apply for configuration 2.

Table 26 contains the DAP configurations for all four reboost configurations. Specific DAP parameters are required for each of the reboost configurations to ensure stability and proper control during the reboost. Particular attention needs to be paid to the deadbands, rate limits, jet modes, and OAs associated with each reboost and ISS configuration.

For each vehicle configuration, 1,000 Monte Carlo cases were run for PRCS and VRCS mated reboosts as well as deboosts. Mass property dispersions of $\pm 10\%$ in inertia and ± 6 inches in center of mass, initial rate error dispersions of ± 0.01 deg/sec, and modal uncertainties of ± 4 dB in amplitude and $\pm 20\%$ in frequency were applied to each of the cases.

For the PRCS mated reboost, an attitude deadband of 10° and a rate deadband of 0.02° /sec are required. The jet control mode must be configured to LowZ (via PBI) with X jets *disabled* (via DAP CONFIG page), and, as with the nominal ALT mode, the forward Y jets deselected. Furthermore, the ALT DAP must be set to 1-jet with 7.04 second delays. Since control authority with ALT is limited, large attitude excursions from the reboost attitude were occasionally seen in simulations for past flights. For such cases, the flight rules state that the reboost is to be terminated when the attitude error reaches twice the deadband. For STS-128, the reduced rate limit of 0.02° /sec provides tighter control, and no attitude exceedances larger than twice the deadband were observed in simulations for the attitudes in Tables 27 and 28. The maximum attitude exceedances are shown in Tables 29 and 30.

For the VRCS controlled reboost, the required attitude and rate deadbands are 5.0° and 0.05° /sec respectively. The normal VRCS control mode is used for reboost, so unlike the PRCS modes, no special jet re-configuration is required. Attitude errors from VRCS reboost simulations remained below 9 degrees in pitch, and below 6 degrees in roll and yaw.

The reboost and deboost efficiencies per the defined configurations are given in Tables 27 and 28. The Orbiter body attitude relative to LVLH is expressed by a PYR Euler angle sequence given in RPY order. Particular attention should be given to the boost attitudes shown. For PRCS, the boost attitudes are TEAs. PRCS boost at other attitudes can lead to significant attitude excursions exceeding twice the attitude deadband, in violation of the flight rule. For VRCS, the optimal boost attitude that aligns the resultant thrust vector from the translational and rotational firings is shown. Attitude offsets are required in Orbiter pitch and roll (ISS pitch and yaw) in order to align the thrust vector correctly and thereby maximize the ΔV along the LVLH +X axis. Failure to conform to these attitudes may result in thrust misalignment and reduce the net ΔV along the LVLH +X axis.




Figure 5: Config 1 Reboost, -Z ALT, Attitude and Rate Errors

Section 5.1 lists the reboost constraints. Sections 5.2 and 5.3 give a summary of expected thruster firings (Tables 31 and 32) and sample plots (Figures 5 through 8) for each reboost configuration.

5.1 Reboost Constraints

- Reboost constraints documented in the Flight Rules
 - Auto reboost modes that utilize the VRCS are limited to a duration of 1 hour and an interval between reboost events of at least 20 hours. There is an additional limit of no more than 3 hours cumulative VRCS reboost per mission.
 - There shall be a 5-minute pause between the end of the maneuver to reboost attitude and the initiation of reboost.
 - Reboost will be terminated if it is observed that attitude errors exceed two times the attitude deadband.
 - The orbiter airlock must be pressurized to a minimum of 3.45 psi prior to reboost.
 - Water dumps, propulsive venting and APU burn-offs are prohibited during reboost.
 - Reboost is not allowed during loaded SRMS, SSRMS, or JEM RMS operations.
 - To avoid IMU ID switching, an IMU will be deselected for the reboost.
 - The cycle ergonometer is limited to a maximum of 67.5 RPM during reboosts using config 1.
- Additional assumptions/constraints
 - Automatic reboost is only certified for the configurations as documented in this memo.
 - Automatic reboost is robust to changes in mass properties for the flight. However control acceleration selections should follow along with mass property configuration and active jet mode. Proper OA selection insures accuracy in DAP feedforward and notch filtering.
 - No attitude maneuvers can be performed while automatic reboost is active.
 - Both the reboost translation and DAP rotation mode must be configured as described for the established reboost mode.
 - High data rate during reboost operations is highly desirable.
 - Downlist of undesired acceleration during reboost is highly desirable.




Figure 6: Config 1 Reboost, -Z ALT, Phase Planes




Figure 7: Config 3/4 Reboost, VRCS, Attitude and Rate Errors




Figure 8: Config 3/4 Reboost, VRCS, Phase Planes

5.4 Reboost/Deboost via Attitude Hold

Reboosts and deboosts can also be achieved without activating the reboost logic by performing a long-term attitude hold. Like the mission specific attitude holds, 100 attitude holds of duration 22,000 sec were run for various ISS attitudes with dispersed mass properties ($\pm 1\%$ in inertia, ± 6 inches in center of mass), initial rate errors ($\pm 0.01^{\circ}/\text{sec}$), and modal uncertainties ($\pm 4dB$ amplitude, $\pm 20\%$ frequency). The attitudes included TEAs based on the July 22 Final ATL, the boost design attitudes given in Tables 27 and 28, as well as the LVLH-aligned attitudes for +XVV and -XVV. Tables 33 and 34 show the average ΔV from holding attitude for reboost and deboost respectively. The Orbiter body attitude relative to LVLH is expressed by a PYR Euler angle sequence given in RPY order. Note that holding attitude at LVLH with ALT yields ΔV_x in the opposite direction as desired (shown in red). Tables 35 and 36 show the propellant usage for the attitude holds.

5.5 Maneuvers to and from Reboost/Deboost Attitudes

Maneuvers to the reboost/deboost attitudes and back were simulated to provide estimates of the resulting ΔV and propellant usage. 100 cases were run for each maneuver with dispersed mass properties (±1% in inertia, ±6 inches in center of mass), initial rate errors (±0.01°/sec), and modal uncertainties (±4dB amplitude, ±20% frequency). Tables 37 through 40 show the average ΔV from the maneuvers and Tables 41 through 44 show the propellant usage. The tables show the Orbiter body attitude relative to LVLH which is expressed by a PYR Euler angle sequence given in RPY order. The simulation duration was 3600 sec.

6 STS-128/17A Maneuver Performance

STS-128/17A has been certified with VRCS for rotational maneuvers with a maneuver rate of 0.10° /sec. However, due to likelihood of poor performance, ALT LowZ±X NFY is not certified for maneuvers and is to be used only if no other control modes are available. The results for ALT maneuvers presented in this document are for reference only. Due to loads constraints, all ALT maneuvers for STS-128/17A mated configurations must be 1-jet with a 7.04 sec delay.

VRCS provides acceptable control for attitude maneuvers. However, as with recent ISS assembly flights, VRCS maneuvers may exhibit some non-ideal behavior during mated flight. One phenomenon observed with VRCS control in pre-flight analysis is toggling of the thrusters during certain rotational maneuvers. When such jet toggling occurs, one or more jets will cycle on and off anywhere from 10 to 60 times over the course of 120 seconds as the desired rate is approached. Toggling such as this is usually mild and not an issue. There is little that can be done about such toggling with the current flight software. Should this toggling become an issue on a future flight, then the only alternative is to reduce the VRCS maneuver rate, as was done with the ALT maneuver rate.

A second phenomenon observed with both VRCS and ALT control is maneuver chasing. For some rotation maneuvers, control authority can be somewhat marginal as compared to the maneuver rate. As the end of the maneuver approaches, the DAP is unable to change the rotational rate fast enough in order for the maneuver to converge upon the desired attitude properly. The commanded rates are changing too rapidly for the jets to be able to respond in time. The end result is that the attitude and rate errors may "orbit" the phase plane until the DAP is able to bring the maneuver to an end, resulting in longer maneuver times and more propellant usage than would otherwise be required. Maneuver chasing was observed in simulation occasionally for VRCS control and for a significant number of cases for ALT control.

6.1 Generic Maneuvers

Both generic maneuvers and mission specific maneuvers have been analyzed for STS-128/17A. The generic maneuvers analyzed were random LVLH maneuvers from one random LVLH attitude to a second random LVLH attitude.

For both the Intermediate1 and Final models, 10,000 generic maneuvers were run with VRCS as well as 1-jet ALT with 7.04 second delay. Initial rate errors up to $\pm 0.01^{\circ}$ /sec were applied per axis. A uniform distribution of modal uncertainties was applied to the flex model ($\pm 20\%$ frequency and $\pm 4dB$ amplitude). Results for the the RRR configuration with and without HTV1 are shown.

6.1.1 RRR




Figure 9: Maneuver Time versus Eigen-angle for STS-128/17A Intermediate1, RRR




Figure 10: Additional Time to Complete Maneuver versus Eigen-angle for STS-128/17A Intermediate1, RRR




Figure 11: Histogram of Additional Time to Complete Maneuver for STS-128/17A Intermediate1, RRR

For the RRR configuration, a plot of maneuver time versus eigen-angle for the Intermediate1 STS-128/17A configuration is shown in Figure 9. The scatter plots are the results of the 10,000 random maneuvers for both ALT and VRCS. For most maneuvers, the maneuver time is close to the eigen-angle divided by the maneuver rate, producing the two bands of points in the plot. Many more ALT maneuvers exhibit maneuver chasing than with VRCS, and thus take longer than the expected time. In fact, there were 28 cases with ALT in which the target attitude was not reached by the end of the simulation (5400 sec). These failed maneuvers, artificially plotted at 6000 seconds in Figure 9, are typically large-angle maneuvers and can usually be completed if given enough time. For the maneuvers that completed in 5400 seconds with ALT, Figures 10 and 11 show the additional time needed to complete the maneuver beyond the expected time.




Figure 12: Total Maneuver Propellant versus Eigen-angle for STS-128/17A Intermediate1, RRR

A plot of the total propellant versus eigen-angle is shown in Figure 12. The linear fits for VRCS and ALT are plotted as dashed lines. As can be seen in the plots, ALT is generally more propellant efficient than VRCS for maneuvers. This difference is primarily due to the reduced maneuver rate for ALT.




Figure 13: Maneuver Time versus Eigen-angle for STS-128/17A Final, RRR




Figure 14: Phase planes for failed ALT maneuver for STS-128/17A Final, RRR

For the Final STS-128/17A configuration, a plot of maneuver time versus eigen-angle is shown in Figure 13. The plot shows significantly more ALT maneuvers taking longer to complete. There are also many failed maneuvers. Table 45 shows the number of cases out of the 10,000 runs that exhibited maneuver chasing or failed. Figure 14 shows a typical failed maneuver.




Figure 15: Total Maneuver Propellant versus Eigen-angle for STS-128/17A Final, RRR




Figure 16: Total Maneuver Propellant versus Eigen-angle for STS-128/17A Intermediate1, RRR HTV




Figure 17: Total Maneuver Propellant versus Eigen-angle for STS-128/17A Final, RRR HTV

6.1.3 Jet Firing Statistics

Tables 46 and 47 summarize the observed jet firing statistics from the Monte Carlo maneuver cases for VRCS and ALT respectively. Both tables contain the combined results of both the Intermediate1 and Final configurations. For the vernier results, the Max-On columns show the on-times statistics of any *single continuous* vernier jet firing. As seen in the table, the maximum continuous on-time for any jet does not exceed the 500 second SODB limit for the configurations shown (for the RxR HTV configuration, there was one case which violated this limit). The Firings column shows that the SODB limit of no more than 1,000 firings in an hour is met for all of the maneuvers. The last columns of data contain the statistics for the total on-time of the given jet over the course of the maneuver. Since ALT limits the on-times to 80ms and there are no constraints on the number of ALT pulses, only the total on-time data is shown in Table 47.

6.2 Mission Specific Maneuvers

All of the mission specific maneuvers as documented in the STS-128/17A Final ATL (July 22, 2009) have been simulated and examined for the RRR configuration (only this configuration was examined since the ATL attitudes are mass property dependent). For each of the maneuvers in the ATL, 100 cases with dispersed mass properties ($\pm 1\%$ in inertia, ± 6 inches in center of mass), initial rate errors ($\pm 0.01^{\circ}$ /sec), and modal uncertainties ($\pm 4dB$ amplitude, $\pm 20\%$ frequency) were run. The results are summarized in Table 48. The maneuver number in the table corresponds to the number given in the ATL for the target attitude. The table shows the Orbiter body attitudes relative to LVLH which are expressed by a PYR Euler angle sequence given in RPY order. Some maneuvers were too small to trip the auto-maneuver logic and thus no true maneuver occurred. The estimated propellant in those cases was the total from the run. The amount of reboost or deboost obtained from performing the maneuvers is given in Table 49. The average ΔV values shown were taken from the end of the simulations (at 3600 sec for VRCS and 5400 sec for ALT).




Figure 18: Post-docking Maneuver Propellant versus Orbiter Pitch Angle for STS-128/17A RRR

The post-docking maneuver was also simulated for 10,000 cases with modal uncertainties of $\pm 4dB$ amplitude and $\pm 20\%$ frequency. The simulations were initialized with random rate errors up to $\pm 0.01^{\circ}$ /sec in roll and yaw, and pitch errors ranging from -0.04 to -0.01° /sec. Each run started with a random free-drift period of duration 800 to 2400 sec. Then the DAP was moded to LVLH for 300 seconds, followed by FREE and then AUTO to start the maneuver. The total propellant is plotted versus Orbiter pitch angle in Figure 18.

7 STS-128/17A Attitude Hold Performance

STS-128/17A has been certified with two jet control modes for attitude hold — VRCS and ALT LowZ \pm X NFY; the certified DAP settings are listed in Table 50. Single-jet ALT mode with 7.04 sec delay time is the only ALT configuration certified for this mission.

As with previous flights, different attitude and rate deadbands are assigned for attitude holds and maneuvers for STS-128. There are two reasons to have separate deadbands for attitude holds and maneuvers. The first reason is that ISS has levied a tighter requirement on errors at undocking. The second reason is for reducing propellant usage while holding attitude at an unstable TEA. These two factors necessitate a reduction in attitude and rate deadbands in order to meet attitude control requirements.

The main reason for the VRCS attitude hold DAP is the undocking rate required by ISS [4]. With the increase in ISS mass, the ISS control system is challenged to maintain control in the face of the undocking disturbances. A requirement for rates no higher than 0.020°/sec at undocking has been levied against the Orbiter DAP. For VRCS, the expedient solution is to drop the rate deadband to below the requirement. With a decrease in rate deadband, a concomitant decrease in attitude deadband is prudent to maintain good control. Thus the attitude hold DAP for VRCS is specifically designed to meet the ISS undocking requirement.

However, the VRCS attitude hold DAP has benefits beyond that of just undocking. First, the deadband reduction will reduce the rates that the ISS control system must deal with when handing over control from the Orbiter to the ISS. This will improve ISS control system convergence times and reduce stress on the ISS jets and CMGs. Second, since the ISS is no longer rotationally stable due to the truss build out, the reduced deadbands will significantly decrease propellant usage for the most part.

7.1 ISS Attitude Envelope




Figure 19: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RRR (y=180°, r=0°)

The usual suite of pitch attitudes from the nominal –XVV ISS assembly attitude envelope was run for STS-128/17A for the six visiting vehicle configurations (RRR, RRx, RxR, RRR HTV, RRx HTV, RxR HTV). For each pitch attitude between 0° and 30°, 10 cases with dispersed mass properties ($\pm 1\%$ in inertia, ± 6 inches in center of mass), initial rate errors ($\pm 0.01^{\circ}$ /sec), and modal uncertainties ($\pm 4dB$ amplitude, $\pm 20\%$ frequency) were run. The yaw/roll offset in ISS is y=180° and r=0°. The attitude hold DAP was used for all results unless otherwise stated. VRCS attitude hold with the maneuver DAP (A12) was performed for RRR for comparison with the hold DAP (B12). Figures 19 through 25 show the propellant usages for VRCS and ALT across the 30° ISS pitch attitude envelope for the Intermediate1 and Final STS-128/17A configurations. Table 51 lists the largest attitude and rate errors during attitude hold with each DAP. The minimum, average, and maximum propellant usage over the envelope for each visiting vehicle configuration are shown in Table 52. For RRR, the propellant statistics per attitude shown in the plots are given for the attitude hold DAP in tabular form in Tables 53 through 56.




Figure 20: STS-128/17A Attitude Hold with maneuver DAP Propellant vs LVLH Pitch Angle, RRR (y=180°, r=0°)




Figure 21: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RRx (y=180°, r=0°)




Figure 22: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RxR (y=180°, r=0°)




Figure 23: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RRR HTV (y=180°, r=0°)




Figure 24: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RRx HTV (y=180°, r=0°)




Figure 25: STS-128/17A Attitude Hold Propellant vs LVLH Pitch Angle, RxR HTV (y=180°, r=0°)

7.2 Random Attitude Holds with ALT




Figure 26: STS-128/17A ALT Random Attitude Hold Errors, Final RRR

To test attitude hold capability with ALT, 10,000 random LVLH attitude holds were performed with dispersed mass properties ($\pm 1\%$ in inertia, ± 6 inches in center of mass), initial rate errors ($\pm 0.01^{\circ}$ /sec), and modal uncertainties ($\pm 4dB$ amplitude, $\pm 20\%$ frequency). Figure 26 shows a histogram of the attitude errors for the Final RRR configuration. With the exception of a few outliers with large roll errors, the attitude errors are not large enough to trigger a maneuver. The maximum attitude and rate errors are shown in Table 57.

7.3 Mission Specific Attitudes

All of the mission specific attitudes to be held under Orbiter control as documented in the July 22, 2009 Final ATL have been simulated and examined. Like the mission specific maneuvers, 100 cases with dispersed mass properties ($\pm 1\%$ in inertia, ± 6 inches in center of mass), initial rate errors ($\pm 0.01^{\circ}$ /sec), and modal uncertainties ($\pm 4dB$ amplitude, $\pm 20\%$ frequency) were run for each mission specific attitude. Results using the attitude hold DAP are summarized in Table 58. The table shows the Orbiter body attitudes relative to LVLH which are expressed by a PYR Euler angle sequence given in RPY order. In comparison, attitude hold with the *maneuver* DAP can use up to three times as much propellant, as shown in Table 59. Note that the attitude hold DAP is required at the undocking attitude. The maximum attitude and rate errors during attitude hold are shown in Table 60. The ΔV from the mission-specific holds is shown in Tables 61 and 62.

The deadband and rate limits for operations with the OBSS extended on the SRMS are constrained by NSTS 07700, Volume XIV, Appendix 8 [15]. For RMS maneuvers with a lightly-loaded arm, the VRCS rate limit is limited to be no less than 0.2 degrees/second, and the deadband no less than 3 degrees.

Single-jet ALT-Tail mode is acceptable for OBSS attitude hold during inspection operations (in the absence of vernier capability), but deadband and rate-limit modifications are required for the same reason as described above. For ALT mode, a deadband of 5 degrees and a rate-limit of 0.2 degrees/second are required. A minimum-impulse ALT on-time and a 6 second ALT delay are required when the OBSS sensors are collecting data. This is done with the intent to minimize the interference from jet activity during data collection.

For Orbiter attitude maneuvers with the OBSS deployed on the SRMS, a 2-jet ALT-mode is required, to reduce jet-pulsing and to provide improved maneuver performance over that of the 1-jet ALT-mode.

8.1.2 Non-Survey Activity (OBSS Extended)

In general, Orbiter-alone operations with the OBSS on the SRMS do not pose attitude control or stability problems. Exceptions to this might be found at extreme extensions of the OBSS, or at very tight (uncertified) deadbands and rate limits. Although the OBSS is a relatively light payload, it has a large center-of-mass displacement, and may not fall within the bounding assumptions for generic payloads.

Although the RMS/OBSS extension does not, in general, raise control or stability concerns, other technical disciplines depend on forcing-function data from EG/Draper for their certification. Such data have only been provided for specific RMS angles and under specific DAP conditions.

Two different RMS/OBSS positions have been analyzed at various stages of undocking and separation. The joint angles for these 2 positions are:

8.1.3 Contingency: Loss of a side-firing Vernier Jet – non-mated operations

For non-mated Orbiter attitude control, the loss of a side-firing vernier jet does not cause loss of control. However, for certain critical operational phases, attitude control in 5-jet mode is either undesirable or not certified, as indicated below.

- Certified:
 - Orbiter-alone attitude control
 - OBSS TPS surveys
- Not certified:
 - Rbar Pitch Maneuver (RPM)
 - Rendezvous

8.2 Mated OBSS TPS Surveys

Mated OBSS operations, with SRMS or SSRMS, are not a concern from an attitude-control point of view, because of the large inertia of the base-body and the small payload mass. However, procedures written for unmated operations may not be appropriate while mated. For example, tail-only PRCS control for Orbiter-alone is a standard control mode; but for current Orbiter/ISS mated configurations, tail-only PRCS control is not a viable option.
