Your grade for this course will be based on a percentage score, with each category weighted as follows:

- All mastery objectives complete by deadline dates = 40%
  - $\rightarrow$  All <u>written exams</u> passed without error by the end of the next exam date (or end of quarter, whichever comes first)

Please note the importance of completing all mastery objectives by their deadline dates. Failure to complete *any* mastery objective in time deducts 40% from your total score. If this happens, it means the highest possible score you can earn for the course will be 60%, which is below the 70% threshold for a C-, the lowest passing grade. In other words, you *must* complete all mastery objectives by their due dates in order to pass the course, regardless of any other score.

Deductions to your course grade are based on your preparation for and participation within each theory session. Failure to arrive on time to a theory session, or arriving with incomplete preparatory work for that session results in a -1% deduction per session. Failure to positively and proactively contribute to the discussion during a theory session also results in a -1% deduction per session. Showing up on time, fully prepared, and genuinely contributing to every theory session is the *minimum* expectation.

A failing (F) grade will be earned if any mastery objectives are past deadline, or for any of the following behaviors: false testimony (lying), cheating on any assignment or assessment, plagiarism (presenting another's work as your own), willful violation of a safety policy, theft, harassment, sabotage, destruction of property, or intoxication. These behaviors are grounds for immediate termination in this career, and as such will not be tolerated here.

If for some reason you know you will be late or absent, submitting your work in electronic form (e.g. email attachment) prior to the scheduled time is acceptable for full credit. The standards are just as high for electronic submissions as for face-to-face demonstrations:

- For <u>theory session preparation</u>, submission of all assigned work (e.g. reading outline and reflections, answers and work for all assigned questions) before the scheduled start time of that theory session will count as full credit.
- For <u>theory session contribution</u>, answering all "Challenges" for assigned questions will count as full credit.
- For <u>experiments</u>, video documentation of you completing all objectives in their proper order will count as full credit.
- For projects, video documentation of you completing the objective(s) will count as full credit.

Absence during a scheduled exam will result in a 0% score for that exam, except in the case of a *documented emergency*.

# Question 0

# How to get the most out of academic reading:

- <u>Outline, don't highlight!</u> Identify every major idea presented in the text, and express these ideas in your own words. A suggested ratio is one sentence of your own thoughts per paragraph of text read.
- <u>Articulate your thoughts</u> as you read (i.e. "have a conversation" with the author). This will develop *metacognition*: active supervision of your own thoughts. Note points of agreement, disagreement, confusion, epiphanies, and connections between different concepts or applications.
- <u>Work through all mathematical exercises</u> shown within the text, to ensure you understand all the steps.
- <u>Imagine explaining concepts you've just learned to someone else</u>. Teaching forces you to distill concepts to their essence, thereby clarifying those concepts, revealing assumptions, and exposing misconceptions. Your goal is to create the simplest explanation that is still technically accurate.
- <u>Create your own questions</u> based on what you read, as a teacher would to challenge students.

# How to effectively problem-solve and troubleshoot:

- <u>Rely on principles, not procedures.</u> Don't be satisfied with memorizing steps learn *why* those steps work. Each step should make logical sense and have real-world meaning to you.
- <u>Sketch a diagram</u> to help visualize the problem. <u>Sketch a graph</u> showing how variables relate. When building a real system, always prototype it on paper and analyze its function *before* constructing it.
- <u>Identify</u> what it is you need to solve, <u>identify</u> all relevant data, <u>identify</u> all units of measurement, <u>identify</u> any general principles or formulae linking the given information to the solution, and then <u>identify</u> any "missing pieces" to a solution. <u>Annotate</u> all diagrams with this data.
- <u>Perform "thought experiments"</u> to explore the effects of different conditions for theoretical problems. When troubleshooting, perform *diagnostic tests* rather than just visually inspect for faults.
- <u>Simplify the problem</u> and solve that simplified problem to identify strategies applicable to the original problem (e.g. change quantitative to qualitative, or visa-versa; substitute easier numerical values; eliminate confusing details; add details to eliminate unknowns; consider simple limiting cases; apply an analogy). Remove components from a malfunctioning system to simplify it and better identify the nature and location of the problem.
- <u>Check for exceptions</u> does your solution work for *all* conditions and criteria?
- <u>Work "backward"</u> from a hypothetical solution to a new set of given conditions.

## How to manage your time:

- Avoid procrastination. Work now and play later, every single day.
- <u>Consider the place you're in</u> when deciding what to do. If there is project work to do and you have access to the lab, do that work and not something that could be done elsewhere (e.g. homework).
- <u>Eliminate distractions</u>. Kill your television and video games. Turn off your mobile phone, or just leave it at home. Study in places where you can concentrate, like the Library.
- <u>Use your "in between" time productively.</u> Don't leave campus for lunch. Arrive to school early. If you finish your assigned work early, begin working on the next assignment.

Above all, cultivate <u>persistence</u>, as this is necessary to master anything non-trivial. The keys to persistence are (1) having the desire to achieve that mastery, and (2) realizing challenges are normal and not an indication of something gone wrong. A common error is to equate *easy* with *effective*: students often believe learning should be easy if everything is done right. The truth is that mastery never comes easy!

# Checklist when reading an instructional text

"Reading maketh a full man; conference a ready man; and writing an exact man" - Francis Bacon

Francis Bacon's advice is a blueprint for effective education: <u>reading</u> provides the learner with knowledge, <u>writing</u> focuses the learner's thoughts, and <u>critical dialogue</u> equips the learner to confidently communicate and apply their learning. Independent acquisition and application of knowledge is a powerful skill, well worth the effort to cultivate. To this end, students should read these educational resources closely, write their own outline and reflections on the reading, and discuss in detail their findings with classmates and instructor(s). You should be able to do <u>all</u> of the following after reading any instructional text:

 $\checkmark$  Briefly OUTLINE THE TEXT, as though you were writing a detailed Table of Contents. Feel free to rearrange the order if it makes more sense that way. Prepare to articulate these points in detail and to answer questions from your classmates and instructor. Outlining is a good self-test of thorough reading because you cannot outline what you have not read or do not comprehend.

 $\checkmark$  Demonstrate ACTIVE READING STRATEGIES, including verbalizing your impressions as you read, simplifying long passages to convey the same ideas using fewer words, annotating text and illustrations with your own interpretations, working through mathematical examples shown in the text, cross-referencing passages with relevant illustrations and/or other passages, identifying problem-solving strategies applied by the author, etc. Technical reading is a special case of problem-solving, and so these strategies work precisely because they help solve <u>any</u> problem: paying attention to your own thoughts (metacognition), eliminating unnecessary complexities, identifying what makes sense, paying close attention to details, drawing connections between separated facts, and noting the successful strategies of others.

 $\boxed{\checkmark}$  Identify IMPORTANT THEMES, especially GENERAL LAWS and PRINCIPLES, expounded in the text and express them in the simplest of terms as though you were teaching an intelligent child. This emphasizes connections between related topics and develops your ability to communicate complex ideas to anyone.

 $\checkmark$  Form YOUR OWN QUESTIONS based on the reading, and then pose them to your instructor and classmates for their consideration. Anticipate both correct and incorrect answers, the incorrect answer(s) assuming one or more plausible misconceptions. This helps you view the subject from different perspectives to grasp it more fully.

 $\checkmark$  Devise EXPERIMENTS to test claims presented in the reading, or to disprove misconceptions. Predict possible outcomes of these experiments, and evaluate their meanings: what result(s) would confirm, and what would constitute disproof? Running mental simulations and evaluating results is essential to scientific and diagnostic reasoning.

 $\checkmark$  Specifically identify any points you found CONFUSING. The reason for doing this is to help diagnose misconceptions and overcome barriers to learning.

# General challenges following a tutorial reading assignment

- <u>Summarize</u> as much of the text as you can in one paragraph of your own words. A helpful strategy is to explain ideas as you would for an <u>intelligent child</u>: as simple as you can without compromising too much accuracy.
- <u>Simplify</u> a particular section of the text, for example a paragraph or even a single sentence, so as to capture the same fundamental idea in fewer words.
- Where did the text <u>make the most sense</u> to you? What was it about the text's presentation that made it clear?
- Identify where it might be easy for someone to <u>misunderstand the text</u>, and explain why you think it could be confusing.
- Identify any <u>new concept(s)</u> presented in the text, and explain in your own words.
- Identify any <u>familiar concept(s)</u> such as physical laws or principles applied or referenced in the text.
- Devise a <u>proof of concept</u> experiment demonstrating an important principle, physical law, or technical innovation represented in the text.
- Devise an experiment to <u>disprove</u> a plausible misconception.
- Did the text reveal any <u>misconceptions</u> you might have harbored? If so, describe the misconception(s) and the reason(s) why you now know them to be incorrect.
- Describe any useful <u>problem-solving strategies</u> applied in the text.
- <u>Devise a question</u> of your own to challenge a reader's comprehension of the text.

# General follow-up challenges for assigned problems

- Identify where any <u>fundamental laws or principles</u> apply to the solution of this problem, especially before applying any mathematical techniques.
- Devise a <u>thought experiment</u> to explore the characteristics of the problem scenario, applying known laws and principles to mentally model its behavior.
- Describe in detail your own <u>strategy</u> for solving this problem. How did you identify and organized the given information? Did you sketch any diagrams to help frame the problem?
- Is there <u>more than one way</u> to solve this problem? Which method seems best to you?
- Show the work you did in solving this problem, even if the solution is incomplete or incorrect.
- What would you say was the <u>most challenging part</u> of this problem, and why was it so?
- Was any important information <u>missing</u> from the problem which you had to research or recall?
- Was there any <u>extraneous</u> information presented within this problem? If so, what was it and why did it not matter?
- Examine someone else's solution to identify where they applied fundamental laws or principles.
- <u>Simplify</u> the problem from its given form and show how to solve this simpler version of it. Examples include eliminating certain variables or conditions, altering values to simpler (usually whole) numbers, applying a <u>limiting case</u> (i.e. altering a variable to some extreme or ultimate value).
- For quantitative problems, identify the <u>real-world meaning</u> of all intermediate calculations: their units of measurement, where they fit into the scenario at hand. Annotate any diagrams or illustrations with these calculated values.
- For quantitative problems, try approaching it <u>qualitatively</u> instead, thinking in terms of "increase" and "decrease" rather than definite values.
- For qualitative problems, try approaching it <u>quantitatively</u> instead, proposing simple numerical values for the variables.
- Were there any <u>assumptions</u> you made while solving this problem? Would your solution change if one of those assumptions were altered?
- Identify where it would be easy for someone to go astray in attempting to solve this problem.
- Formulate your own problem based on what you learned solving this one.

• "Inverted" theory sessions

 $\rightarrow$  There is *no* lecture, because lecture places students in a passive state of mind when they need to be actively engaged with the subject matter. An "inverted" structure is used instead, where students independently study the subject matter in advance, then share what they learned *during* class sessions.  $\rightarrow$  Students sign up for an hour-long theory session each day, no more than eight students per session, between the hours of 12:00 Noon and 3:00 PM.

 $\rightarrow$  The course document specifies tutorials to read and outline, and questions to answer, prior to each session. This preparatory work takes the place of lecture.

 $\rightarrow$  Theory session work is graded on the basis of good-faith effort rather than accuracy or correctness. At the start of each session, each student's preparatory work (e.g. <u>written outline</u> for the assigned reading and <u>work shown</u> for all assigned questions) will be checked and recorded by the instructor. A second mark is given for <u>contributing helpfully</u> to the dialogue, and not just asking for help. Grade deductions (-1% each) are levied for each instance of unpreparedness or non-participation. In the event of absence, electronic submissions of your work by that session's start time will be accepted for full credit.

 $\rightarrow$  The instructor dialogues with students during the session, answering questions, posing new questions, monitoring students' problem-solving, and offering helpful advice.

# • Labwork

- $\rightarrow$  Students will individually conduct scientific <u>experiments</u> by stating hypotheses, designing experiments to test those hypotheses, collecting data from those experiments, and analyzing the results.
- $\rightarrow$  Students will diagnose faulted circuits, either by computer simulation or on actual circuits.

 $\rightarrow$  Students will collectively design, construct, and test practical <u>projects</u> either individually or in small teams.

 $\rightarrow$  Video-recording of labwork is recommended, and recordings showing all necessary details (e.g. identity of the student, time and date, all experimental parameters, conclusions, etc.) may be used as evidence of objective completion in lieu of the instructor being present to witness.

 $\rightarrow$  A "Terminal Block Board" is provided to each student for the construction of experimental circuits, and will displace solderless breadboards whenever possible. Students may take these home, but they will be inspected and returned to the college at the end of the course, with the student responsible for repairing any damage.

# • "Mastery" assessments

 $\rightarrow$  A "mastery" assessment or objective is something required in order to pass the course.

 $\rightarrow$  A "mastery" exam is one that cannot be passed unless all questions are correctly answered. Multiple opportunities are given to re-take (different versions) of every mastery exam. The percentage score earned on the *first* version taken is the only one recorded for grading.

 $\rightarrow$  Lab objectives (e.g. experiments, trouble shooting, and projects) are mastery, in that they must *all* be completed to professional standards in order to pass the course. A percentage score is given based on the number of attempts required to meet the standard of each objective. Late completion results in a zero score.

- Students are responsible for completing all assigned work, for doing their *own* work, checking their email accounts for messages, safeguarding and presenting instructor-signed records of progress, maintaining the lab rooms and assigned equipment in good working order, and contacting the instructor prior to any absence.
- A failing grade will be earned if any mastery objectives are unmet by the end of the school day on the deadline date, or for any of the following behaviors: false testimony (lying), cheating on any assignment or assessment, plagiarism (presenting another's work as your own), willful violation of a safety policy, theft, harassment, sabotage, destruction of property, or intoxication.

# • Self-defeating behaviors include the following:

 $\rightarrow$  Impatience – expecting immediate success in endeavors where patient attention and hard work is necessary.

 $\rightarrow$  Bluffing – claiming to confidently understand rather than asking good questions and seeking resources.  $\rightarrow$  Lack of initiative – procrastinating on deadlines, waiting for others to tell you what to do, not preparing for future exams and assignments, etc.

Numerical answers must be within 1% of the correct (un-rounded) answer in order to be counted as correct.

The written exam is a mastery exam, which means passing the exam requires *all* questions be answered correctly, and that passing this exam is necessary to pass the course. If upon your first submission to the instructor any errors are found, the instructor will mark which sections of the exam have been passed (with "1" characters) and which sections have not (with "0" characters), and will return the exam to you for another attempt. If upon your second submission any errors remain (or new errors added), you must re-take a different version of the exam on a different day. Scoring is based on the number of attempts: the number of "1" marks divided by the total number of "0" and "1" marks. The score from the first version of the exam you take factors into your course grade. Re-take exams are not scored, but only checked for absence of all errors by the second submission. Exam re-takes occur during lab time, a maximum of one per day.

Following the written exam will be a <u>demonstration exam</u> where you will build a circuit at your desk using your Terminal Block Board and then demonstrate its correct operation to the instructor. A multimeter is permitted, but the circuit must not be energized with any form of electrical source except during demonstration. Circuit demonstration occurs at the front of the classroom where you will be given **2 minutes** to set up and demonstrate its correct operation to the instructor. If the demonstration is unsuccessful, you may return to your desk to fix the problem(s) and then re-try with the same time limit. The demonstration exam is closed-book, but component "pinout" references are allowed.

The demonstration exam is also a mastery exam, with re-takes (maximum of one per day) allowed. The exam's score is based on the number of attempts (e.g. 1 attempt = 100%; 2 attempts = 80%; 3 attempts = 50%; 4 attempts = 10%; 5 or more attempts = 0%). Any violation of a safety standard (e.g. handling energized conductors) counts as a failed attempt.

Demonstration circuit parameters will be randomized by the instructor. Students will be made aware of the circuit options well in advance of the exam in order to master the necessary principles and procedures, but exact component values, test conditions, and other details will not be revealed until the exam begins. Terminal Block Boards must be "blank" (i.e. no pre-placed or pre-wired components) in order to ensure every student actually builds their own circuit during the exam session. Any re-takes after the scheduled exam date will be with new (randomized) circuits.

This exam's demonstration circuit is a <u>four-resistor series-parallel resistor circuit</u> energized by a DC voltage source. The instructor will provide the circuit schematic diagram, the resistor values, and the voltage source value. Your task is to accurately predict resistor voltage drops, then demonstrate that the measured voltages match your predicted voltages.

A scientific calculator is allowed, but no use of mobile phones or personal computers as calculators. Music played through earbuds is welcome. You may ask questions of the instructor, who will clarify questions but will not provide hints or any other form of help. Numerical answers must be within 1% of the correct (un-rounded) answer in order to be counted as correct.

The written exam is a mastery exam, which means passing the exam requires *all* questions be answered correctly, and that passing this exam is necessary to pass the course. If upon your first submission to the instructor any errors are found, the instructor will mark which sections of the exam have been passed (with "1" characters) and which sections have not (with "0" characters), and will return the exam to you for another attempt. If upon your second submission any errors remain (or new errors added), you must re-take a different version of the exam on a different day. Scoring is based on the number of attempts: the number of "1" marks divided by the total number of "0" and "1" marks. The score from the first version of the exam you take factors into your course grade. Re-take exams are not scored, but only checked for absence of all errors by the second submission. Exam re-takes occur during lab time, a maximum of one per day.

Following the written exam will be a <u>demonstration exam</u> where you will build a circuit at your desk using your Terminal Block Board and then demonstrate its correct operation to the instructor. A multimeter is permitted, but the circuit must not be energized with any form of electrical source except during demonstration. Circuit demonstration occurs at the front of the classroom where you will be given **2 minutes** to set up and demonstrate its correct operation to the instructor. If the demonstration is unsuccessful, you may return to your desk to fix the problem(s) and then re-try with the same time limit. The demonstration exam is closed-book, but component "pinout" references are allowed.

The demonstration exam is also a mastery exam, with re-takes (maximum of one per day) allowed. The exam's score is based on the number of attempts (e.g. 1 attempt = 100%; 2 attempts = 80%; 3 attempts = 50%; 4 attempts = 10%; 5 or more attempts = 0%). Any violation of a safety standard (e.g. handling energized conductors) counts as a failed attempt.

Demonstration circuit parameters will be randomized by the instructor. Students will be made aware of the circuit options well in advance of the exam in order to master the necessary principles and procedures, but exact component values, test conditions, and other details will not be revealed until the exam begins. Terminal Block Boards must be "blank" (i.e. no pre-placed or pre-wired components) in order to ensure every student actually builds their own circuit during the exam session. Any re-takes after the scheduled exam date will be with new (randomized) circuits.

This exam's demonstration circuit is a <u>three-input combinational logic circuit driving a 120 VAC load</u>. The instructor will provide a truth table as well as the AC load, for which you will select the appropriate components (gates and/or relays). All power for this circuit will be provided on the Terminal Block Board, and the toggle switches on your Board will serve as inputs to the logic circuit. Your task is to demonstrate that the circuit implements the correct truth table and that the load does not harm any of the other circuit components.

This includes unsafe work practices (-20%), improper equipment usage (-10%), poor teamwork (-10%), etc. Expectations include maintaining an orderly work environment and returning all tools and test equipment by the end of every day, as well as following clear instructions (e.g. instructions given in equipment manuals, learning modules, verbally by the instructor), communicating with teammates, and productively managing time.

#### Objective descriptions and standards

## Prototype diagram and project scope

Prior to any construction, the team must present diagrams of what they intend to build along with a description of what the project will do. For this particular project the prototype documentation includes a completed truth table for the combinational circuit, schematic diagram showing all components (switches, logic gates, interposing components, AC load, etc.), and 120 VAC load selection. The prototype diagram(s) must include all components, component values, wiring connections, code outline, etc. The project scope is a written description of what the completed project should actually do, and it should be as practical and reasonable as time will allow. This step is critically important, as poor planning leads to poor project execution!

# Risk assessment/mitigation plan

The team must assess all risks associated with the project's construction and operation, both equipmentrelated and personal, along with practical steps to mitigate those risks. This project will involve 120 VAC electrical power, and therefore there is a non-trivial risk of electrical shock and fire. To address this you will need overcurrent protection and wiring practices appropriate for 120 VAC line power.

# Project timeline and action plan

The team will present a simple timeline of expected construction and testing progress, culminating at the project deadline date. Deviations from this plan may occur, but it is still important to formulate a plan in order to budget time and resources.

# Demonstration of working system

The team will demonstrate proper operation of the project. For this particular project, the 120 VAC load must energize only when the correct input conditions are met, as documented in the truth table.

## Project diagrams and coding

Each individual team member will present their own copy of diagrams for the project using industrystandard formats and symbols. Any programming code must also be fully documented, complete with comments written within the text of the code.

#### Bill of Materials

The team will present a simple Bill of Materials listing all components and materials necessary to build the project, along with current cost estimates for each. Assembled devices given to students (e.g. Terminal Block Boards) need not have their internal components itemized but may be listed as single line-items in the Bill of Materials. The total cost of a Terminal Block Board is about \$200.

## Written summary of lessons learned

Each individual team member will present their own written summary describing key points they learned during the construction and testing of the project. It is strongly encouraged that everyone document their own mistakes, as they *will* inevitably occur, and it is important that they serve as learning opportunities. The scope of this summary may be as wide as you wish, reflecting on everything from technical lessons learned, to interpersonal lessons learned, to ways of improving time management, etc.
